## Vision: A Community Responder Program for Bloomington/Monroe County

**Goal:** Improve the safety of the community by sending the most qualified emergency responders in response to 911 calls.

# What is a Community Responder Program (CRP)?

A CRP is an emergency response service that does not involve the police and is instead staffed by mental health professionals. It can be run directly by a local government or a local government can contract with a nonprofit organization to provide the services. More information and examples found here.

## What are the benefits of a CRP, as measured by programs in other cities?

- 1. Provides a better, more effective response to several different types of calls for service that are more appropriately met by a social service intervention than a law enforcement intervention.
- 2. Reduces exposure to armed police, potential use of force, and entanglement with the criminal legal system, thereby reducing harm for, in particular, low-income people and communities of color that are historically overpoliced and overexposed to these dangers.
- 3. Allows police to focus on responding to, investigating, and solving violent crime and other emergencies that more appropriately call for an armed response by freeing up time previously spent on these calls.
- 4. Reduces criminalization of behavior that stems from mental health or substance misuse and does not in itself constitute a crime.
- 5. Diverts calls from Fire, EMS, and/or emergency rooms, thereby reducing costs and overcrowding of ERs.

#### Common features of CRPs

- 1. Teams of 2-3 responders including a social worker. Often other team members include a peer counselor and an EMT. All have specialized training.
- 2. Dispatched through the 911 Central Dispatch system requires training of dispatchers, and is usually limited to certain hours of operation. When the CRP is not operating, the calls go to police, fire, or EMS.
- 3. The CRP team takes time to not only resolve the immediate emergency but connect the person to services AND follow up with the person in the coming days.
- 4. When not on calls, the CRP teams build relationships with members of the community who are unhoused or otherwise underserved.
- 5. CRP teams have radio contact with police in case they need backup. Most programs have found that armed backup is rarely needed.

### **Current options in Bloomington**

- 911 Dispatch has one social worker position
- BPD employs 4 social workers, but they are embedded and work for police (See #2 above, under Benefits)
- Stride Mobile, run by Centerstone, has limited staff not linked into 911 system
