4. Public comment

Limit 5 minutes per person, 20 minutes total

Alex Jorck is a member of the Bloomington Commission on Sustainability. They are working on a SPEA capstone project. It involves a municipal electric utility running alongside private utilities as a way to provide 100% clean energy.

The capstone project is to conduct a feasibility study on this type of program in Bloomington. The EC could look at research questions, engage throughout the project, and potentially a recommendation from the EC at the end.

It is expected to happen from January – May 2026, the spring semester at IU. Alex will send the submitted proposal for the EC to view.

5. New Business

a. Annual Planning Meeting (Carrie)

We expect this to happen at our November meeting. Commissioners are encouraged to bring food for the group. We will review goals from last year and decide what to proceed with in 2026.

b. Handbook Revision* – Quorums for Working Groups and Full Commission (Carrie)

The low quorum limit is causing trouble for larger working groups. The goal is to change the quorum definition to allow larger working group meetings to occur without them becoming a full EC meeting. The group agreed to remove the "minimum of five (5)" from the determination of quorum.

The commissioners decided to not change language around requiring working group membership / participation.

6. Old Business

a. Working group updates

i. Water Quality

The working group spoke with utilities about upcoming changes. Many were about formalizing rules and regulations.

A new state law prevents local governments from regulating erosion controls on sites under one acre.

Driveway culverts are now officially required to be maintained by property owners.

The new design manual is in effect.

Street sweeping routes are being updated.

An IDEM grant is available to handle non-point source water pollution. It could involve Clear Creek or the Cascades Park area.

ii. ECPC

1. Letter to October 23 2025 BZA

The group met twice. The St Remy dam wetland and a future housing development were discussed in the first meeting. In the second meeting the group wrote a letter to bring to the Board of Zoning Appeals. The project is being pushed back to the November meeting.

The shorter alternate route was initially considered but negotiations failed. The HOA does not control the entirety of the pond's edge. The EC agreed to have ECPC letters attributed to the ECPC specifically rather than the EC as whole.

iii. Light Pollution

The concerning UDO line mentioned in the September meeting was addressed by planning. Lights on private property are indeed regulated, even across a public right of way.

iv. Biodiversity

Bloomington is officially a dues-paying Bee City member. Shannon recommended some sort of public announcement. Carrie may attend a neighborhood association event to spread information about the habitat connectivity map.

Shannon recommended collaborating with neighborhood associations to encourage the use of HAND grants to create rainwater gardens. Carrie is interested in exploring reaching out to those who add to the Habitat Connectivity Map, perhaps with a newsletter. Existing city newsletters may be an option.

Adam F. recommended making the EC's native plant recommendations more easily accessible from the map.

v. Special Projects

Carrie is looking into updating designs for EC materials.

vi. Eco-Heroes

1. Theme discussion

Adam M.: Kill Your Lawn, or predators

Matt: Native plants and wildlife

Carrie: Something light related (sun, light pollution), birds,

"Nature rocks" (geology focused)

Shannon: something around catalogs or archives of living

organisms, rewilding

Heidi: What happens at night?

"Nature at Night" (or similar) – seems to be the winner.

7. Staff Update

a. IDEM Notices

Council member Piedmont-Smith asked if the EC gets IDEM public notices. Rachael receives them via Office of the Mayor. Should they be added to the packet? The EC seems interested only in items likely to be of significant importance to Bloomington.

b. Scheduling – December 2025 meeting date

The current scheduled date, Dec 18th, is still planned.

8. Reports from:

a. Tree Commission (TC)

No update.

b. Environmental Resource Advisory Council (ERAC)

Vegetation management has occurred at several city parks. Callery pear reduction is on track. No spotted lanternflies spotted in Monroe. Griffy parking lot will be paved. The powerline trail is to be installed.

- c. Friends of Lake Monroe (FOLM)
 Science committee will attend a state-wide meeting.
- d. Bloomington Commission on Sustainability (BCOS)
 Approved the capstone project mentioned above by Alex.
 Advanced a resolution to add "resilience" to their name, to be voted on next month.
- e. Monroe County Identify and Reduce Invasive Species (MC-IRIS) Focusing on specific species next year. Annual meeting is October 17th.
- f. Clean Community Program No update.
