



1. Urban Forester's Quarterly Tree Assessment and Reporting (Haskell Smith)- attachment in email
  - a. 1900+ pruned, 300+ removed, plantings, inspections (~30%)
  - b. Some issues with trucks breaking down and staff this year
  - c. 25 hazard trees addressed, new tree grates coming, removed 47 high risk trees that were in TreeKeeper at beginning of year
  - d. IDNR funding awarded for ash tree management (\$50,000 with overmatch to equal 110k)- will get condition rating of around 500 trees to determine

actions

- e. Tree Assistance Program- 16 applicants, waiting to hear back on contract (out for quote and closes Friday 12/19)
- f. In process of reapplying for Tree City USA
- g. UDO and Urban Forest Master Plan
- h. Next year- numbers for pruning about same, less planting (\$), similar #'s of tree removal
2. Report from Environmental Commission (Dave Parkhurst)
  - a. Met November to plan for coming year, water quality committee and light pollution committee discussed, meeting again this week (no agenda yet)
3. Report from Mia Williams (Indiana University Landscape Architect)
  - a. Mia will attend a draft presentation for the newest tree inventory, and will request a “bigger picture” view with the Commission, happy to see IU staff using the data
  - b. Planting was curtailed this fall due to the weather, focus point was the athletics district- successful football season/tailgating did slow down/stop the plantings there, have changed locations of some planned sites, also nurseries are digging later in the fall, so window is narrowed for fall plantings
    - Haskell agrees that ideal planting season is noticeably shorter
4. [Optional] Report from Julie Roberts/Canopy Bloomington
  - a. No report

### Public comment

- a. James- lives near Cottage Grove and neighborhood is planning a protected district (protect trees from demolition which is an issue with developers in area), also a lot of Tree of Heaven coming up in the alleys and HAND is no longer able to help (too busy)
  - a. Julie- can see if Canopy can help in the area, or if Ray from Trees from Seed can help there
  - b. Dave- MC-IRIS could potentially help with the Tree of Heaven if the neighbors were amenable

### New business

- a. Suggestions for tree tags on newly planted trees (George Hegeman)
  - a. Attach (zip tie to tree guard) to newly planted trees with their species and basic care and protection of the tree, potentially include QR codes for TreeKeeper, Tree Care Manual, UF website
  - b. Message from the tree itself- “Hi, my name is \_\_\_\_, I am a \_\_\_\_ tree”
  - c. Each tree planted in 2026, would cost around \$500 total
  - d. Julie moves, Stephanie seconds, all approve for Haskell to start working on this, he will get a rough draft out to the group
- b. Unified Development Ordinance 20.04.080 Landscape, Buffering and Fences Amendments (ac)
  - a. TC can review- special attention to prohibited and approved tree species- only

- include cultivars if substantially different from original species
- c. Urban Forestry Masterplan [Draft]
  - a. TC can review, best by end of week
- d. Julie- two topics
  - a. Include Greek organizations and MC-IRIS and Canopy to work on invasives removal and climate change
    - i. Mia- Heather Reynolds and BUWP do this work in a ongoing way (Steph echoes and can give support as she works with BUWP!)
