*Faris moved to approve the February 27, 2026 meeting minutes. Bishop seconded. Motion carried by a voice vote of 11-0.*

*Martin shared information about three upcoming public comment sessions being held by Bloomington Transit to discuss service improvements to Route 16, which runs between downtown Bloomington to Ivy Tech to the W Bloomfield road in southwest Bloomington.*

*Martin shared an INDOT March 30th 2026 press release regarding a speed limit reduction from 30 mph to 25 mph for state road 46 in Ellettsville between 2nd Street and Paul Street.*

*Martin shared updates from INDOT regarding the implementation of AASHTOWARE Safety Software, which will allow crash data to be displayed and refined at the state level instead at the local community level as it has in the past. BMCMPPO staff may be beta testers for the software.*

*Martin shared that from now on the BMCMPPO (and a couple other MPOs) will be able to utilize the state's (INDOT's) license to upload traffic counts into the INDOT Traffic County Database System (TCDC) instead of us having to pay for our own license account as we have in the past.*

*Martin shared that the State of Indiana has written a draft Active Transportation Report, which is open right now for public comment.*

*Martin reminded everyone to please complete their 2026 Board and Commission Conflict of Interest Questionnaire, which is a requirement for all members and proxies of City of Bloomington boards and commissions.*
- 6.7. [Monroe County map of flood locations and flood signage](#), which includes areas of known flooding, locations of “Road May Flood” signage, and flood hazard data from the DNR  
*Gandhi shared Monroe County’s new map of flood locations. Their map was created in order to fulfill a request from the US Army Corps of Engineers’ Flood Safety and Messaging Signage campaign, who was asking for local information on hazardous flooding areas - either known areas of severe roadway flooding or areas where a fatality has already occurred. The BMCMPPO helped compile a list for the city of Bloomington using crash data.*

*Gandhi briefly shared this resource and highlighted the State of Indiana numbers.*
- 6.9. Extra funds received from INDOT for fiscal year 2026  
*Gandhi shared that the BMCMPPO has received an extra \$47,894 in FY2026 funds, which must be used by September 30, 2026. Allocation of these funds is addressed in items 6.10 and 8.1.*
- 6.10. [Memo regarding April 8, 2026 meeting between BMCMPPO staff and local public agencies](#) to discuss extra fiscal year 2026 funds, changing TIP project construction phase dates, and potential exchanging of funds with another MPO.  
*Gandhi shared that per the meeting described in this memo, the BMCMPPO will propose, through future amendments presented to the committee: to give the extra \$47,894 in FY2026 funds to the Downtown Curb Ramps phase 5 project; and, to move the*



*construction phase years for the Old SR 37/Dillman Road and College & Walnut phase 1 projects.*

The current arrangement means that the City of Bloomington is responsible for hiring, housing, and paying for MPO staff; however, all formal BMCMPPO business remains under authority of the BMCMPPO Policy Committee.*

*Faris moved that the BMCMPPO PC recommend the Office of the Mayor and the Office of the County Commissioners prepare a new interlocal agreement for the urbanized area of Bloomington/Monroe County, as required, to be presented back to the BMCMPPO PC for approval. Thomas seconded. Motion failed by a voice vote of 4-6, with one (1) abstention (Packer).*
