Late June Early July Respite for the Common Council (No Meetings Until a Regular Session and Committee of the Whole on July 13th)

The Council will take an unusual respite before it considers the next round of legislation and the departmental budget hearings in July. That respite and revisions to the July schedule are detailed in the attached notices and a briefly summarized below:

- The Council will meet next on July 13th when it will start the first legislative cycle in July with a Regular Session immediately followed by a Committee of the Whole;
