**4. New Business**

a. Staff Liaison, Rafi Hasan, informed commissioners that the packet of information distributed contains nominees for Outstanding Black Male Leader of Tomorrow, 2 candidates for high school category and 7 candidates for adult. The commission will have to call a special session meet. The special session will occur preferably within a week because the decision has to be made to submit the information to the City of Bloomington and the 2017 Commission for Black History Month Planning Committee.

b. Meeting Tomorrow (2/9) with David Pillar, Principal of Jackson Creek Middle School from 1:00p-2:30p. The CSBM must reduce the number of commissioners in attendance for the meeting with Principal Pillar and Superintendent DeMuth due to governing ordinance for CSBM (If three or more commissioners attend a public meeting notice and 48-hour notice is required). There needs to be talking points and questions about their policy as well as make Mr. Pillar aware of community resources and the commission's role. Find out whether he is still moving forward with the program and how they identified these children and categorized them in this particular classification. There are concerns about the letter, but the program also has a Christian orientation which excludes those of other faiths. Meeting will be a feature story in the Newsletter and possible response to Herald Times article.

c. Response to Herald-Times Editorial Board: Staff Liaison, Rafi Hasan, offered to step in and draft a response that can be a teachable moment to counter misinformation. Mr. Hasan requested for commissioners to send notes and offered to synthesize a response.
