### Call to Order

Meeting was called to order at 5:32 pm.

### **Reports from Commissioners & City Offices**

Scott reports that the Traffic commission has started work on ADA parking changes to the downtown. Steve reported that Blickensdorf and Hawkins were re-appointed by Council, and that other members should continue to serve until replaced by OOTM. Amanda Turnipseed brought to that attention of the commission parking issue in the area surrounding the new SICE building. Specifically that contractors have removed no-parking signs, IU has not parking enforcement jurisdiction in that area, City PE is unwilling to enforce without the presence of signage, and that illegal parking is regularly obstructing ADA pathways and pedestrian walkways. IU Parking and Public Works continue to work together to resolve the issue.

### Public Comment

Mark Stotsberg, Bicycle and Pedestrian Safety Commission, reported on an experience he described as "predatory towing." Specifically: while patronizing a local business Mr. Stotsberg parked his car in an adjacent lot, and stated that at that time, he did not observe "No Parking" signage. His car was towed within ten minutes. Mr. Stotsberg alleged that the towing company employed spotters to surveil the lot and facilitate removal cars, and that this practice, combined with the lack of appropriate signage amounted to a predatory towing practice. Mark Need pointed out that BMC §15.48, Removal and Impoundment of Vehicles, addresses the removal and impoundment of vehicles by the City, but not part of the code addresses removal from private property.

Mr. Thackery, owns a building located at 208 S. Dunn Street, between East 4th and East 3rd Street. The location is a business with employees and has apartments with residents. Mr. Thackery indicated in an email that there is no off-street parking attached to the property, and petitions for relief under BMC §15.37.180, "Business Employees" or BMC §15.37.210, "Kirkwood and Walnut employees." Mr. Thackery's building is located outside of the established boundaries of the residential neighborhood zones, issuance of employee permits is the purview of the Board of Public Works, and the Parking Commission has no authority to grant relief.

### **Discussions of Topics Not the Subject of Resolutions**

The commission reviewed and discussed the attached presentation concerning proposed changes to Title 15, specifically garages and citations. The commission was unanimous in recommending changes to the 3-hour policy in garages and recommended:

- 1 Hour free parking
- Keeping garages post-pay
- Additional interior and exterior signage (wayfinding)
- Improved real-time parking availability

The commission was unanimous in that garage permit rates should be increased, regularly escalated, to code cleanup in section s§15.34.070, §15.40.015, §15.64.010. Consideration of the proposed rates was continued to the February meeting.

At the request of Evans Fernandez, the commission studied violation data sourced from T2 by Blickensdorf to determine the revenue difference of pricing violations based on a tiered structure or and increase in the single rate. Data demonstrated that increasing the cost of violations to \$30/\$60 would cover the 2016 costs of issuing violations without adding T2-related complications of a tiered-violation pricing strategy. Also, based on violation frequency data, the City would generate \$2.1MM at \$30/\$60 vs. \$1.3MM at \$20/\$30/\$50. The commission was unanimous in deciding that fines should be increased to \$30/\$60.

A meeting supplement (attached) covering proposed changes to Garages and Citation was distributed at the meeting to commissioners and members of the public.

# **Recommendation on Permit Prices**
