Dear Ms. Granger and Council Members:

On behalf of the Park of Bloomington Park Commissioners, I am writing to request a change to language governing firearms in the Griffy Lake Nature Preserve. Section 14.20.020 reads that it is "unlawful for any person to shoot any firearm within the limits of the city." It goes on to make several exceptions, including "any contractor of the city of Bloomington Board of Park Commissioners hired for the purpose of deer reduction via sharpshooting at Griffy Lake Nature Preserve." We ask that this be amended to also include hunters at that site.

Deer overpopulation at the 1,200 acre Griffy Lake property has been well established by numerous reports over the years (Joint City of Bloomington-Monroe County Deer Task Force, research by Dr. A. L. Shelton from the Indiana University Department of Biology). The large number of deer has caused ecological damage as well as a rise in deer-vehicle collisions near the area. After a number of alternatives (fencing, trapping, etc.) were considered and rejected, a sharp shooting program was carried out at Lake Griffy in the winter of 2017-2018. It was very successful and 62 deer were killed. Thanks to the efforts of Steve Cotter, of the parks department, the department was recently awarded a \$32,500 grant through the state's Community Hunting Access Program to facilitate a hunt at Lake Griffy to further reduce the deer population. White Buffalo, Inc., the same company that managed the sharp shooting last year, will train and oversee hunters chosen for the event. Hunts are tentatively scheduled for Nov. 17, 18, 24, 25, Dec. 1, and 2. A private security firm will be hired to patrol the area during the hunts to ensure safety.

It is our hope that a controlled hunt of deer at Griffy Lake Nature Preserve, similar to those that have worked well in Indiana's state parks, will help in restoring the area's biodiversity.
