# **III. Public Comments**

- Paul Ash reported the Bicentennial event on the B-Line this weekend was successful.
- Kay Bull reported debris in the bike lane on West Third Street due to trucking companies
- Kay Bull reported that the center line at the intersection of 3rd and Curry could use additional bike symbols.
- Kay Bull report that's difficult to get to the bike path on 3rd Street bridge when travelling eastbound in traffic
- Kay Bull reported that the Rally's drive through design is hazardous for pedestrians.
- Kay Bull suggested the Pace bike share bikes should be equipped with mirrors.

- Jacklyn Ray shared that there's now a bike lane on the bridge on Rogers around 11th. They are great.
- Julia Karr noticed there are some new bump-outs around Fairview School at Kirkwood and Maple that kids can use to cross the street. It feels safer to stand on the bump out and see traffic better.
- Jim Rosenbarger got feedback on a new build-out at Woodlawn and Atwater that was positive.
- Mark Stosberg reported University Elementary PTO is planning a walking school bus program which would use the new saver crossing at Tamarron Dr and 10th.
