# \*\*Kinzie moved to approve the Consent Agenda. Kappas seconded\*\*

2 members of the public commented on the Consent Agenda. One included questions about the typology for the Hunter Greenway and what the Transportation means for Hunter in the future. Rosenbarger explained that Hunter is already a part of the Bicycle Network and there are no current plans to fulfill what is detailed in the Transportation Plan on Hunter. There would be public meetings before these changes proceed. Another member of the public raised concerns about Hunter becoming an automobile heavy road.

Hoffmann and Sandberg emphasized that what is detailed in the Transportation Plan regarding Hunter is only a plan. All of the plans in the Transportation will not come to fruition. Hoffmann put on the record that the Transportation Plan provides that as a multi-modal path for bicycles, there is an intent to have a continuous path for a bicycle to go the entire length of existing Hunter, but the Transportation Plan does not have plans to make the one-block stretch into an automobile road.

C) Amendment to change Typology Recommendations for portions of E. 3rd Street and portions of S. College Mall Road

D) Amendment to make changes to the Pedestrian Priority Areas map

E) Amendment to add a recommendation for Pedestrian and Bicycle tunnels under I-69 Ramps

8 members of the public commented on the B amendments, including voicing concerns about Walnut & College two-way streets, cost of the study, emphasizing the possibility of turning Walnut & College into two-way streets should not be taken away, defense of Amendment B3, and safety for alternative transportation.

Hoffmann responded to several of the questions and concerns from the public comment period.
