All persons seeking approval for a parking request are encouraged to contact the City Planning and Transportation Department as early as possible to schedule a pre-application meeting. This meeting is required and must occur by the deadline listed in this schedule.

Following the pre-application meeting with Planning and Transportation staff, the project will be reviewed. Once an application has been filed, the deadline for submitting any revisions or additional information to staff is two weeks prior to the Parking Commission meeting, or as specifically noted in this schedule.
