Meeting Called to Order

## **Guests speakers:**

Ruben has facilitated the meeting with the Martinsville Police today. Chief Wiltermood and Deputy Chief Maurer gave a presentation on what they are doing to improve communication and relationships with underrepresented communities.

Ricardo states the Commission should get statistics on how often Latinos are pulled over and for what infractions.

Ruben states the CHLA could act as a communication channel for the Latino community to voice concerns to the police chief.

Gavin states that the CHLA can invite the MPD to some of the cultural events put on by the city or the CHLA.

## Health Committee :

Shelley: The VIM clinic is currently in the application process to become a Federally Qualified Health Center. This is highly competitive and extremely time consuming. However, if we are awarded the grant it will allow the clinic to expand its services and meet the needs of more underserved people in our community. If we are awarded the grant, the operations and process of the clinic will change but we will continue to see non US citizens who do not qualify for health insurance. It will be very important that accurate information is given to the community. We don't want people to go without care. I am already hearing from patients who think they will not be able to come to the clinic. If you hear concerns please ask them to talk with us. Receiving

# Education :

Gavin/Ricardo: BBBAF - Dates are set as May 14th, May 17th and 18th. Tuesday will be a Street Performance/Block Party. Artists from the Latinx, African-American Community and potentially First Nation will be performing. Additionally, fraternities and sororities representing POC will be invited to participate with dances, lines and stomps. Friday will be an evening event at the Ivy Tech Waldren. This is not a confirmation of fundraising, rather an idea to ponder. Saturday will be the all ages/family event at Banneker Community Center. Here artists will be able to "table" and sell/showcase their art and services. Both groups have expressed interest in engaging with our community.
