II. Domestic Violence and Child Welfare in Indiana- Elizabeth Bullock (DCS)

- A. DCS data (charts included in slides)
 - 1. January 2019:29 substantiated claims, over 200 unsubstantiated cases
 - 2. 71% of substantiated claims were neglect (drug use and DV most common)
 - 3. 445 children and 227 families receiving services from DCS
- B. DCS hotline number: 1-800-800-5556
 - 1. All calls received are screened for DV
 - 2. All reports will be assigned that allege that a child witnesses or was present in the home during an incident of DV
- C. Who should report?
 - 1. Indiana is a mandatory reporting state
 - a) Any person who has reason to believe a child is being abused or neglected should make a report
 - b) Medical professionals, teachers and law enforcement have a higher duty to report abuse or neglect
 - 2. What scenarios often prevent people from reporting?
 - a) Attorney-client privilege

- (1) Elizabeth will follow up to clarify this
 - (a) Is there an immediacy exception?
- b) Worry that a report will cause more issues
- D. Initiation timelines
 - 1. If law enforcement agency is on the scene and has requested assistance, DCS will respond within 1 hour to the scene
 - 2. Any reports of current alleged DV will be initiated in 24 hours
 - 3. Any reports of alleged DV within 48 hours will be initiated in 24 hours
 - 4. Any reports of DV more than 48 hours ago and child(ren) are not believed to be in danger will be initiated within 5 days
 - 5. Any call involving children under the age of three is a mandatory 24 hour initiation
- E. Assessment prep
 - 1. Prior to contacting the family DCS will:
 - a) Contact law enforcement for previous law enforcement contacts
 - b) Check DCS system for previous assessments
 - c) Search MyCase and MyCourts.in.gov for criminal history and protective orders
 - d) Determine if a detective is already on the case
- F. Conducting the assessment
 - 1. Assessment involving DV does not warrant an automatic removal to ensure safety of children
 - 2. Struggle to keep children safe without penalizing the non offending parent
- G. Required interviews
 - 1. All interviews should be performed separately
 - 2. All interviews must be performed without the alleged DV offender present
 - 3. Talk to non offending parent before interview
 - 4. If both parents are listed as offending parents, then DCS can use exigent circumstances
 - 5. Interview order
 - a) Children
 - b) Parents
 - (1) Try to talk with non offending parent without the offender
 - (2) Non offending parent does not always disclose
 - (a) Always ask about safe times to make future contact
 - c) Witnesses
- H. Interviewing children
 - 1. Three guiding principles (included in slides)
 - 2. DCS will not disclose any information any information learned from the non offending parent with the child(ren)
- I. Factors of assessment
 - 1. Age
 - 2. Developmental status
 - 3. Understanding of safety

- 4. Ability to participate in own safety
- 5. Rick based on neglect/abuse type
- 6. Parents' acknowledgement of problem
- 7. Parents willingness to change
- 8. Access to other safe adults
- J. Interviewing offender
 - 1. Information from non-offending parent or children is not shared (only information from 3rd parties)
- K. Safety planning
 - 1. Safety plan with children and non-offending parent is not shared with offender when possible
 - 2. Safety plans made with other entities can be used
- L. Protective Orders
 - 1. DCS will not force a parent to file a protective order
 - a) If DCS feels that safety of the child cannot be maintained, the child will be detained
 - b) DCS will provide the <u>option</u> of a protective order to parents as part of safety planning
- M. Intervention options
 - 1. Community resources
 - 2. Informal adjustment
 - a) Approved by judge
 - b) DCS provides services 6-9 months
 - 3. In-Home CHINS
 - a) Active court case, but children remain in the home
 - b) In the care of the state, but remain with the parents
 - 4. Removal
- N. Child and family team meetings
 - 1. Case managers sit with the children and family to plan
 - 2. Parents decide who participate in meetings
 - a) Can invite advocates
- O. Closing a case
 - 1. Has safety improved and has the reason for intervention been corrected to the best of our ability
- P. Questions
 - Can DCS file protective order for a child against the offending parent?
 a) No
 - 2. What does DCS do if the family declines a team meeting?
 - a) DCS will look into and can escalate
 - 3. How are the adjacent counties grouped?
 - a) Region 13
 - b) Region 9
