1. Call to Order

5. Old Business

- a. WHM Lunch March 25, 2020; Theme: Valiant Women of the Vote"
 - i. Debby stated the subcommittee is working on a list of potential speakers (local, regional, and national) and have come up with around twelve. The subcommittee plans to narrow down the list during next month's meeting.

 - i. Registration is free; held in Showers building.
 - ii. Focus on Latina and Black middle school and high school age girls.

 - 1. Focus on team building/ice breaker exercises.
 - 2. Discussed the Quality of Place Report and focused on: affordable housing, low unemployment (Multiple jobs per person? Misleading?), precepted diversity.
- b. High School Liaison
 - i. Kai gave the commission on the clubs benefiting women at her school
 - 1. FAIRE Feminism Activist Club; recruited about 40 students despite minor harassment.
 - 2. New Clubs: Human Dignity Project (body positivity), Women in Politics, Ladies of the Century (empowering young girls).
 - ii. Outside of school: North and South HS GSA had a joint booth at Bloomington Pride which was well attended.
- c. BCSW Youth Award
 - i. Nana provided a draft of the proposal for discussion.
 - ii. Ashley suggested an essay about a woman who has promoted/improved the status of women.
 - iii. Debby reminded the commission to focus on a girl who she, herself, has promoted/improved the status of girls/women in their community. Also, self-confidence concerns regarding selfnomination vs community nomination? Debby suggested some strong language encouraging self-nomination.
 - iv. Kai supported both self and community nominations and joined the youth award subcommittee.
 - v. Nic suggested the award proposal include trans inclusive language and have a teen-friendly entry form (digital).

- vi. Amanda reinforced the topic of the award need not be a famous woman, but could be a locally relevant woman to the young nominee.
- vii. Nana will present a modified draft at the next BCSW meeting.
