Recommendations

The committee met on May 22, 2020 and conducted its business electronically with members and participants accessing the meeting from various locations. The meeting, in summary, included: an overview of 12 March 2020 discussion on transition in the Council Office; acknowledgement of receipt of retirement letter from the current Attorney/Administrator – which established a vacancy starting August 1, 2020; discussion of next steps; and a motion to recommend action by the Council, which was adopted by a vote of 3 - 0 -0 (Cm. Rollo was absent), which is set forth below.

(T)he Administration Committee recommends that the Council appoint Stephen Lucas to serve as the Council Attorney/Administrator effective August 1, 2020, pending resolution of certain employment matters by Cms. Volan and Sims, which include such matters as compensation and continued interest in the position.








Application Volumes
