- I. Call to Order and Introductions
  - a. Satterly called the meeting to order.
- II. Approval of the Meeting Agenda\*
  - a. Porter moved to approve the meeting agenda. Haley seconded. Motion passes unanimously by roll call vote.
- III. Approval of Minutes\*
  - a. February 26, 2020
    - (1) Rhoads moved to approve the February TAC minutes. Tolloty seconded. Motion passes 6-0-3 by roll call vote.
  - b. April 22, 2020
    - (1) Porter moved to approve the April TAC minutes. Satterly seconded. Motion passes 8-0-1 by roll call vote.
- IV. Communications from the Chair and Vice-Chair
  - a. None
- V. Reports from Officers and/or Committees
  - a. LPA Project Updates
    - (1) Satterly reported for Monroe County. Fullerton Pike Phase 2 is finishing up with pavement markings and will be completed this spring. Fullerton Pike Phase 3 is going through a preliminary field check phase. Ask Paul for an invite if you are interested in seeing the project. The Curry/Woodyard/Smith project is currently in the bidding phase. The Karst Farm Greenway project will be in the Request For Proposal for design phase soon.
    - (2) Kopper reported for the City of Bloomington. The Rogers/Henderson/Winslow project's construction is going well. The Downtown Crosswalks project is moving along well. The 17<sup>th</sup> Street project is moving along well but with some delays. The 2<sup>nd</sup>/Bloomfield project recently had a final walkthrough completed and will be finishing up soon.

  - (a) Clemens reported that the MTP Public Survey is live and ready for distribution to the public. Please pass this survey link to your groups or access it on the MPO's MTP website.

  - (a) Martin reported that the UPWP has been approved by the Policy Committee and INDOT earlier this month. Discussion ensued.

  - (1) Chapter 2 Guiding Principles: An extended discussion.
    - (a) Martin discussed the MTP with a major focus on the Guiding Principles chapter. Discussion ensued. Clemens reiterated the importance of taking and passing along the MTP Public Survey because it will help guide the development of the 2045 MTP.

# VIII. New Business

- a. FY 2020 2024 Transportation Improvement Program Amendment\*
  - (1) DES#170763, 170764, 170765, 170766, 170767 Bloomington Transit Grimes Lane Facility Improvements
    - (a) Martin introduced the TIP Amendment. Noojin commented on the necessary repairs by saying they are mainly routine maintenance projects for structures of that age (25 years or more).
  - (2) DES#0902215 Bicentennial Pathway Phase I construction along Old SR 37 from Audubon Road to Robinson Road for a distance of 2.3 miles.
    - (a) Satterly discussed this TIP Amendment. He mentioned that funding would be best used to widen this roadway for bicycle transportation with focus on the uphill portion of the bike route. The route will be completed once additional funding becomes available.

Porter moved to recommend support of both TIP Amendments to the Policy Committee. Tolloty seconded. Motion passes unanimously via roll call vote.

    - (1) Martin noted that Next Level Trail funding has been suspended for projects not yet under contract, even if they have been announced, due to state budget shortfalls
