In the Council Chambers of the Showers City Hall at a meeting held on Wednesday, February 5, 1997 at 7:30 PM with Council President Pizzo presiding over a Regular Session of the Common Council.

Roll Call: Banach, Mayer, Young, Pizzo, Service, Sabbagh, Sherman, Pierce. Absent: Cole.

Pizzo gave the Agenda Summation.

The minutes of January 22, 1997 were approved by a voice vote.

Mayer noted the death of Jack Morrison, former and long time councilmember, this past week.

Young also remarked about Morrisons' death. He congratulated Police Chief Kennedy for the good job he is doing as chief and thanked him for his year of service.

Service also commented on Jack Morrison and his concern and attention to the needs of his constituents. While he was a very political person, he wasn't a partisan person. She spoke about his willingness to provide TVs and refrigerators for Democratic Hgts in election years while doing it with good humor. She hoped that the ongoing discussion about reinstating the Voter Registration Board would be scrapped and that the deliberately partisan nature of past board activities is not conducive to an open registration process.

Sabbagh thanked George Malacinski for his financial support of Frank Southern Skating Rink and especially for his financial donation to Girls Inc.that creates and makes a skating rink scholarship possible.

Pizzo said that the deliberations for Social Service Funding (CDBG) have been completed and he said that 23 agencies requested \$362,902 and \$163,942 will go to social service agencies. After 4 years of being on this committee it is still a gut-wrenching experience making these difficult funding decisions.

Mayor Fernandez welcomed and introduced Tim Lawson, newly appointed City Engineer. He then read an Encomium for Fire Chief Larry Fleener, thanking him for all his years of dedicated service to our community first as a firefighter and then as Fire Chief for the City of Bloomington.

Larry Fleener thanked everyone for their presence here this evening and support over the years. It has been a very rewarding career and he thanked former Mayors McCloskey and Allison for their confidence and support over the years. He said that when newly appointed Fire Chief Saunders takes over next week she will be inheriting 82 of the best firefighters in Monroe County.

Marc Brostoff, Ice Rink Task Force Chairman, thanked the council and specifically David Sabbagh for their assistance in getting this feasibility study and task force report process to fruition. He thanked everyone who has volunteered and been involved in trying to work toward a solution. Now the real work will begin and that is to find a way to fund this project and the strategic plan to provide ice in Bloomington. There will be 3 working groups: Community Relations, Fundraising Committee/Activities, and a Facility Planning/Decision Committee. Again, he encouraged anyone who is interested to get involved with what will be a very challenging and rewarding opportunity to provide ice in Bloomington.
