Pizzo gave the Agenda Summation.

There were no minutes for approval.

Pierce commented on the recent news about TCI (our cable provider) entering into a partnership with Insight, a new cable provider. He said he felt positive about the change as smaller companies have traditionally been more responsive to their users than the giant, 14 million subscriber based companies. He hoped that this new partnership will create a clean slate and hopefully allow us to clear the air and begin anew with cable issues and concerns.

Sabbagh congratulated both BHS North and South for their efforts to collect food for the needy as part of the Fat Cat Collection competition. He also congratulated BHS South on their wonderful football season and the strong showing last Saturday in the state finals. He also hoped that we could get beyond thinking that cable TV is the only consideration that our Telecommunications Council addresses and that we need to be looking forward to discuss some other needs and issues.

Service announced upcoming Board and Commission openings and urged people to take the step and get involved with city government. She also commented on a recent visit to Toronto, Canada and the wonderful diverse ethnic population, low crime level, wonderful restaurants and downtown and a -"Space-port type City Hall"

Cole commented on the recent newspaper articles and letters regarding the traffic calming devices along East First Street in the form of speed bumps and after driving on them, believed that they work very well, look good and make a lot of sense and do exactly what they are intended to do.

Mayer recognized our city street department for the great job they do and in particular the good job they are doing cleaning the leaves from the storm drain grates.

Mayor Fernandez gave the council copies of the Sanitation mailings that will go out next week for next years recycling schedules as well as the magnets that people have found to be such helpful reminders. He said that some of the spring/fall cleanups would be adjusted to accommodate the big traditional moving schedules in our university community.

Steve Sanders, Chairman of the Human Rights Commission, said that this year, the commission voted to create a Human Resources Award to be awarded annually and would recognize people or organizations in our community who are making improvements toward civil rights, civility and human relations. This year Susan Beerman, Principal at BHS North and her committee are the recipients of this award.
