The list is attached to the ordinance. All materials must be stored inside the building and cannot be warehoused outside.

Joe Landrey, the petitioner, was present and clarified some questions about the actual address of the site. He said that the proposed landscaping would act as a buffer for the IU recycling area that is located there.

Cole hoped that the Vernal Pike businesses would keep this corridor clean and attractive as it is an important entry to our city.
