In the Council Chambers of the Municipal Building held on Wednesday, December 1, 1993 at 7:30 P.M. with Council President Jack Hopkins presiding over a Regular Session of the Common Council.

Roll Call: Sherman, Service, Hopkins, Miller, White. Swain, Pizzo, Cole and Kiesling arrived after start of meeting.

Hopkins gave the agenda summation.

There were no minutes for approval.

Service recognized AIDS awareness day. She noted the importance of such events. Sherman agreed with Service. The death of Bill Wilson, musician, was announced and Sherman said he will miss him. He then congratulated the Bloomington South High School Football Team on its 5A State Championship. Hopkins presented an encomium for the Bloomington South High School Football Team for its accomplishments and its 5A State Championship.

Mike Davis, Deputy Mayor, said that signs were being made to commemorate the Bloomington South 5A Football State Championship. He then read the Mayor's Proclamation recognizing World AIDS Day in Bloomington.

The lights in the Council Chamber were dimmed from 7:45 P.M. to 8:00 P.M. to commemorate World AIDS Day.

Davis recognized various events throughout the country for World AIDS Day. He then introduced Jill LaFon, Director of Project FIND, who has worked extensively with the health crisis. LaFon stated that World AIDS Day is the only internationally recognized day of coordinated action that relates to AIDS and HIV infection. Spreading information is one of the most important goals of the

information is one of the most important goals of the project. 1993 saw the sharpest increase in new cases of AIDS in Indiana since records have been kept. She stressed that educating our youth was of primary importance. She presented AIDS awareness pins to the Councilmembers.

Davis recognized members of the Community Action Group. He then recognized Students Organized Against Poverty, who recently held a free market to help the impoverished in the area.

Greg Raisman, Director of Students Organized Against Poverty, said 1200 people came to the market, 2.5 tons of clothes were given away, 400 pounds of bread and baked goods were handed out and 500 people were provide with future services from various city departments, services and organizations.

Hopkins thanked Davis, LaFon, and Raisman for their efforts.

Raisman came pack to the podium and thanked everyone who made the free market possible. The list includes IUSA Taxi office, Bloomington Warehouse and Storage, White Rabbit, Another Campus Pizza and Rib Joint, Sam the Clown, Sarah Westhouse, Delta Sigma Pi, Habitat for Humanity, Community Kitchen, Hoosier Hills Food Bank, Womens Wheels, IU Residence Halls, Kroger, Bloomingfoods, Rock 92 Radio, Bloomington Voice, The Herald-Times, The Indiana Daily Student, and the agencies that provided services, and Channel 8 WISH TV.

Bill Riggert, City Engineer, said that the property at Showers must be acquired from IU, but to do this it must first be cleared for transfer. To get the property clear for transfer the city must vacate a sliver of property that the building encroaches onto city property. He gave a detailed description of the situation. All proper authorities have given the go ahead.

Pizzo asked if access to Eighth Street was going to change. Riggert said that Eighth Street would access the plaza through the parking lot. Hopkins asked if some access from Eighth Street would be closed. Riggert said access would be from the east. Pizzo said that the Council would be vacating a portion of Eighth Street then. Riggert said the city would actually encroach on Eighth, not vacate it so that access to Eighth Street could be reopened. Hopkins said that he thought Pizzo was asking if the vacation would effect Eighth Street. Riggert said it would not. Hopkins said that the purpose of the vacation was simply to clear the title. Kiesling asked if the vacation was only a foot or two wide. Riggert said that it was so. Service was concerned, along with the Farmers Market, that the parking lot would not have proper shade for The Farmers Market Board did not want to the market. move because of the lack of shade. Kiesling said at the last Board meeting there was a lot of discussion regarding the move. Riggert said another Board meeting was scheduled for 12/8/93. He also said that the plaza would have Maple trees which would provide shade, Service asked about the interior of the lot. Riggert gave an idea of what the current plan was. Service said the issue was not the fringe but the interior and whether those trees would provide good enough shade. Kiesling said that more landscaping work is being done and it was not being communicated well to the Board. The ordinance received a roll call vote of Ayes:9, Nays:0. It was moved and seconded that Resolution 93-19 be

Merrifield said that the program served the purpose of making golf accessible to all the citizens who wished to play. White asked if the waiver program still existed. Merrifield said that it did.

Swain asked if the department had received any calls regarding the increase. Underwood said that they had not. Swain commented on the recent press coverage of this increase.

Friedmeyer said the neighbors were happy that the lights in parking lot were back on and that the empty building would be filled. They were also happy about the clean up of the site. Cole asked if the facade of the building was discussed. Friedmeyer said that it had been and that the colors would be muted and controlled. . Y Lynne Coyne, representative of petitioner, said that the liquor store would only be 4,000 of the 29,000 square feet of the building and that he would answer any questions the Council had. Sherman asked how many stores he anticipated in the center. Coyne said that the number of tenants was unknown but that several uses were possible, and he listed some of the more likely ones. Kiesling said that whatever happened there it would be an improvement. Service explained her no vote.
