Hopkins thanked the Bloomington Human Rights Commission for addressing MESSAGES FROM the problem of "gay-bashing" in Bloomington. White also commented on the hearing held by the Bloomington Human Rights Commission. Indiana University will break ground for the new Recreational Facility this Friday. He also congratulated the Bloomington Law Enforcement and Court System for their recent awards from the Middle Way House. Miller wished good luck to all of the candidates in the upcoming election. Swain congratulated his soccer team members and their families for having a successful season. He also offered a reminder of the United Way Fundraiser. Sherman discussed the good work that is coming out of a group that meets and attempts to address the community's environmental concerns. He also announced the birth of his first grandchild, Joseph Robert. Kiesling mentioned the fundraising event for the United Way Agency. She commended the State for offering a Family Leave Plan. She encouraged the public to vote on November 2, 1992.

Mike Davis, Executive Assistant to the Mayor, spoke against the recent gay MESSAGE FROM THE bashing incidents. He read a proclamation designating October as Domestic MAYOR Violence Awareness month. He again offered comments on the recent fundraising efforts of the United Way.

Amanda Shaw spoke of the high PCB contamination in the proposed sight of PUBLIC INPUT extension of Highway 46 into Ellettsville.

Penny Anderson, from Human Resources announced the awards recently given to persons, agencies or businesses for progress in providing improved handicapped facilities.

Davis replied that it would.

White questioned the places for infrastructure development and if this would be completed before any annexations.

Davis explained that there could not be any improvements outside of the city. Hopkins commented that he felt ordinances should be able to make some changes when necessary. He stressed the importance of building affordable housing.

Sherman discussed the importance of recognizing that Bloomington has concerns for its residents.

Swain asked for a clarification on the area discussed.

Davis explained and discussed the proposed expansion.

White asked Davis if money from the fund should be used for service improvement for newly annexed property.

Davis explained that it could be interpreted to include this use.

Kiesling stated that perhaps other money could be used until the revenues begin to roll in.

Cole questioned when the area would be annexed.

Davis responded that it is proposed for 1995.

Shirley Calvert, former President of Housing Solutions Board, spoke in support of the proposed ordinance.

Mark Stewart, Housing Solutions, also came before the Council to support the ordinance. He offered an definition for the people this ordinance would be assisting.
