AGENDA SUMMATION

The minutes of February 15, 1989 were approved by a voice vote.

APPROVAL OF MINUTES

Kiesling announced the regular Saturday recycling schedule and the placement of a drop bin at Kroger's Seminary Square for glass and aluminum. She also announced the ongoing public discussions about the Jackson Creek Watershed Plan. She said she has heard from members of the Plan Commission and the BZA regarding the Council's vote on the W. 11th Ogle rezoning and she wondered what kind of message we are sending our community and commissioners when we (the Council) overturn decisions.

Young wished Olcott a speedy recovery.

Service said that in the current issue of ARTS INDIANA 170 names are mentioned as "State Treasures" and that 65 of those names are from Bloomington...another strong reason for an Arts Center.

White announced the start of Cable TV for the North Jordan area residents (2,000 persons) and was pleased that TCI and IU came together in a good agreement.

Fernandez also wished Olcott a quick recovery and thanked everyone who participated in the recent public forum about the Food and Beverage Tax/Convention Center discussion. He also announced a meeting next week at Utilities regarding ash disposal. He announced that Service had neglected to mention that Pam Service, Author, is also mentioned in the State Treasure category, a fact she modestly neglected to announce. He thanked local representatives Kruzan and Bales for their support for the hotel/motel tax.

Mayor Allison presented an encomium for Ruth Sonneborn, who recently died, to Sandra Anderson, the current director of Planned Parenthood. Allison also wished Councilmember Olcott a speedy recovery and thought he had gone to extraordinary means to see an I.U. basketball game this evening. The Mayor also proclaimed this week as PUSH Week, People Understanding Severly Handicapped and commended Pi Kappa Phi fraternity (national) and I.U.'s Alpha Psi for their support of the project. March 4 and 5 will be PUSH days in Bloomington.
