In the Council Chambers of the Municipal Building held on Thursday, February 5, 1987, at 7:30 P.M. with Council President Mayer presiding over a Regular Session of the Common Council.

Mayer gave the agenda summation.

The minutes of January 21, 1987 were approved by a voice vote.

Service, who testified before a State Senate Environmental committee, urged support of the pending "bottle bill". While passage of the bill does not seem hopeful, she urged Bloomington residents to consider the spirit of the bill, "Removing litter from our streets and parks benefits all of us".

Porter announced that he will not file for re-election this year. He said he has enjoyed his years on the Council, but he added, "it's a young man's game" (I'm not so sure of that).

Olcott noted that while going through some old ordinances he found Resolution 68-40 urging continued efforts for a county-wide parks system and if it was not successful, then, out of city residents would pay a 100% fee increase. The more things change the more they stay the same. Porter noted that he was on the County Council when that resolution was passed.

Gross, Foley, Murphy and Young all thanked Porter for his years of service and were sorry he would not seek another term. Mayer too thanked Porter and Service for her attention to Senate Bill 288.

Regester said the Capital Improvements Committee has put forth a three year plan and comments and input are very much welcome.

APPOINTMENTS TO BOARDS AND COMMISSION It was moved and seconded that Ordinance 87-4 be tabled at the request of the petitioner. It was approved by a roll call vote of Ayes:9, Nays:0.

Olcott moved and Foley seconded the motion that Ordinance 87-5 be introduced and read by title only. Clerk Williams read the ordinace.

Olcott moved and Foley seconded the motion that Ordinance 87-5 be adopted.

Tim Mueller said he was still unprepared to make a recommendation. He said Ted Najam was here this evening, representing the petitioner, with an amended legal description that excluded 144' from the vacated tract. Mueller said there are also unresolved questions regarding storm and sewer lines and stated that Najam suggested the Council pass the ordinance based on the contingency that the problems be worked out before the Mayor signs the ordinance.

Murphy said that was an inappropriate suggestion, leaving contingencies to the administrative branch and noted he did not recall ever doing that before nor being asked to for that matter. Olcott asked why the petitioner was in such a hrrury.

Ted Najam said the 144' would accomodate the apartment complex access route. Monika and Peter Kroener,owners of the complex have objected to the original vacation request, siting problems with fire truck access if the entire tract were to be vacated.

Murphy asked about the "need" for the vacation and Mueller said he was hard pressed to understand the reasons for the request. When the staff reviews vacation requests an entire list of requirements must be met or at least addressed. "Need" is one of the requirements. Also easement concerns from Redevelopment have not been reviewed. Mueller said the criteria for vacation is a long established process and now that the statute dictates that the Council is the only hearing body, "it's yours", he said.

Porter and Regester wanted the legal description straightened out before any approval was given. Service said she agreed with them and noted that a major reason has not been demonstrated for the need for the vacation.

Mayer announced that this was a public meeting and public input was welcomed. There was no comment from the public.

It was moved and seconded that this ordinance be discussed and considered and continued to the Regular Common Council Meeting on February 18, 1987.
