It was moved and seconded that Appropriation Ordinance 86-4 be tabled. The motion carrried by a roll call vote of Ayes:9, Nays:0.

Olcott moved and Foley seconded the motion that ORD. 86-17 Ordinance 86-17 be introduced and read by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Foley seconded the motion that Ordinance 86-17 be adopted. Mayer gave the committee report. Mayor Allison was very pleased with this ordinance pertaining to the use of smoke detectors. She thanked Councilmember Murphy and all of the people who worked so hard on this particular piece of legislation.

The ordinance received a roll call vote of Ayes:9, Nays:0.

Olcott moved and Foley seconded the motion that ORD. 86-18 Ordinance 86-18 be introduced and read by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Foley seconded the motion that Ordinance 86-18 be adopted. Mayer gave the committee report.

There was no discussion and the ordinance received a roll call vote of Ayes:9, Nays:0.

Olcott moved and Foley seconded the motion that Ordinance 86-19 be introduced and read by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Foley seconded the motion that Ordinance 86-19 be adopted. Mayer gave the committee report.

Mayor Allison said that the committee that worked on this ordinance was probably the longest running committee in memory; and that the long period of time allowed landlords and tenants alike to work out their problems and reach a better understanding of each other's problems and concerns. Regester said the main purpose of the committee was to get rid of ambiguities and undefined procedures. The new ordinance also attempts to provide a consistency in the perception of the Code. Service still had reservations about exterminators coming into rental units against the wishes of the tenants.

David King said that in SF structures that are infected, sometimes something can be worked out with the landlord and if he is willing to go along with the insect problem then the tenant concerns are honored. In the case of MF, and neighbors are complaining, then that is something that cannot

be ignored. King said they try not be be inflexible for the most part. Gross expressed concern about the four year inspection cycle and reminded people that a call can still be made and that an inspection will follow any complaints. Regester said that he hoped the landlords would do a good job publicizing the ordinance so that all tenants would know of their rights.

The ordinance received a roll call vote of Ayes:9, Nays:0.

It was moved and seconded that the following ordinances be introduced and read by title only by the Clerk for first reading. Joe Loop questioned the USB policy not allowing City Chemist Ron Smith attend a national professional COMMUNICATIONS meeting in New York. Smith's request was denied and Loop questioned that it seemed odd that we can send people to conferences and meetings that occur and not send our chemist to a meeting that might be helpful and informative in dealing with the problems we have here in this community and county.
