In the Council Chambers of the Municipal Building held COMMON COUNCIL on Wednesday, March 27, 1985, at 7:30 P.M. with Council SPECIAL SESSION President Gross presiding over a Special Session of MARCH 27, 1985 the Common Council.

Roll Call: Service, Porter, Regester, Gross, Mayer, ROLL CALL Foley, Young. Absent: Murphy.

Gross gave the agenda summation.

Service discussed some of the comments she has heard since the public comment on the consent decree was cut short by the public demonstration at last weeks meeting. She said that people said they were surprised that she voted for the decree. She assured everyone that she was not duped or was not being blackmailed by any of the parties involved, pressured, yes, but certainly not blackmailed. Service said that she had concerns about the decree, that the decree was not perfect and she voted for the decree because she is an environmentalist. "There is an environmental problem in our community and there is not a wide variety of options available to us", Service said. She said she doesn't trust the EPA or Westinghouse and because of that distrust it is very important that the City has input to prevent Bloomington from becoming the toxic waste disposal center of the midwest. Service, in response to people expressing concern for babies and children, reminded people that she lives here too and has a child that is growing up in Bloomington as well, and that as tired as everyone is, we cannot afford to drop our vigilance. "This is just the beginning".

Young wished the Mayor a Happy Birthday. Mayor Allison's birthday is tomorrow.

Gross commended the Council regarding last weeks chaotic council meeting and said she was proud to be a member of the council.

Mayor Allison complimented the Council for their courageous composure at last weeks meeting and she told Service MESSAGES FROM that she appreciated her comments and feelings regarding MAYOR the decree.

Allison then presented an encomium for Regina Miller who is retiring from a two year term as president of the Arts Commission. She commended Miller for her many accomplishments and hundreds of hours of time for various community projects that enhance our community; the Fourth Street Art fair, Octubafest, the Taste of Bloomington and countless other projects.

There was no legislation for second reading.
