In the Council Chambers of the Municipal Building held on Wednesday, July 31, 1985, at 7:30 P.M. with Council President Gross presiding over a Special Session of the Common Council.

Roll Call: Service, Regester, Porter, Olcott, Gross, Mayer, Murphy, Foley. Absent: Young.

Council President Gross gave the agenda summation.

The minutes of July 17, 1985 were approved by voice vote.

Service said that over the years she had disagreed with the Herald-Telephones editorial policies and has always been a little hurt that she never got a personal onion. This week she, or the Council, got two onions, one for the salary for elected officials and one regarding the jail property land acquisition issue. She felt the onions were unjust; first of all she was not in favor of the salary increase for the council and secondly the questions about the jail, the marketability of the present municipal building and finally the costs of each facility are certainly legitimate questions. The H-T would probably give them onions if they didn't consider them more carefully.

Regester agreed with Service and that he was committed to see the entire project completed as designed and he was confident that things would get worked out.

Olcott agreed and felt that if the Council had said "let's buy", there would have been an editorial against the Council.

Murphy said that he was still waiting for the wet bar that the H-T suggested would appear in the municipal building. (That was some time ago in reference to another issue).

Mayor Allison referred any inquiries regarding the wet bar to Mr. Murphy and commended the Council for being prudent regarding the jail property. "There will be a number of alternatives before the Council and there will be an opportunity to evaluate each one". She complimented Linda Runkle, Frona Powell, the Telecommunications Council and TCI for the excellent negotiation process that has created the proposed franchise agreement. She noted that the consultant has been very helpful in the deliberations.
