In the Common Council Chambers of the Municipal Building held on February 16, 1983, with Council President Dilcher presiding over a Regular Session of the Common Council.

Council members present: Morrison, Towell, Porter, Service Dilcher, Murphy, Olcott, Gross, Hogan.

Council President Dilcher gave the agenda summation.

Service thanked the people who attended the Griffy Lake hearing that took place in Council Chambers on February 14, 1983. Town Theatre's next production is The Hollow.

There was no Mayoral message.

Gross moved and Murphy seconded the motion that the following persons be appointed to Boards and Commissions:

The motion was adopted by an unanimous voice vote.

Tim Mueller addressed the Council regarding the upcoming Carl Smith PUD rezoning. The site and the plan are very controversial, there have been numerous hearings and presentations about this plan and he urged councilmembers to view the site if possible before the committee meeting next week.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 83-5 by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 83-5. Towell gave the committee report.

Gross explained that she would be changing her previous committee position vote. She said that it would be inappropriate to give this decision function to an administrative board; that this should be a matter for an elected council to make these decisions. Automatic spot zoning could be a disaster.

Morrison urged the council to be practical. It is ridiculous for the city to determine what a business can or cannot do. If the members of a board cannot be trusted to make a decision, then the council should be more responsible in who they appoint to these city boards and commissions. "Lets help local business and the local businessman he isn't going to do something to deliberately harm his neighborhood".

Towell said that this ordinance sets very fundamental criteria for expansion and the way it is now set up the city would then have to grant exceptions. The Board of Zoning Appeals would have the discretionary powers to grant approval but not refuse proposals. The basic problem is that no mechanism would exist for bringing zoning changes into conformity with the basic plan. He continued by saying that he was unhappy with an ordinance originating from the Planning Department that seemed to be a reaction to another zoning request, namely the Eberle proposal.

Olcott had reservations on how this code amendment should be handled but felt there were many instances where up-zoning would benefit everyone.

Hogan said that the council was the appropriate body to determine rezoning requests and that the Zoning Appeals Board will not have the latitude to allow actual re-zoning. COMMON COUNCIL REGULAR SESSION FEBRUARY 16, 1983

Tim Mueller said that there had been staff concern about the implications of rezoning and did not suggest rezoning the entire site.

Ted Najam said that what is proposed in the ordinance is consistent with what the Plan Commission has determined. He thought it was signifigant that no remonstrance of any kind has been filed against this rezoning request.

Hogan said this was an excellent proposal for expanding use, that it is an improvement to the east side and that we should not structure laws to make it more difficult for business men to expand.

Olcott, Morrison and Porter all expressed support for this rezoning.

The ordinance received a roll call vote of Ayes: 7, Nays: 2. (Service, Dilcher).

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 83-4 by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 83-4. Towell gave the committee report.
