In the Common Council Chambers of the Municipal Building held on March 2, 1983, at 7:30 P.M. with Council President Dilcher presiding over a Regular Session of the Common Council.

Council president Dilcher gave the agenda summation.

Service commented on the watercolors hanging in the council chambers at the present time and announced the Town Theatre production of The Hollow and Measure for Measure that will be the next production. She also warned people of the danger of eating PCB contamminated fish that comes from Clear Creek.

Olcott said that he would support any efforts toward a joint law enforcement facility. The city is missing a real opportunity to enhance law enforcement within the community and to continue cordial relations with the county. He was sorry that the Mayor did not support the facility.

Gross said that she supports the joint project as well. She thanked the many people involved in trying to coordinate the effort, the county council, Bob Mann, the Auditor and the many citizens who are interested in better jail facilities.

Dilcher said that all appropriation ordinances must originate with the Mayor and even if the Council passed a resolution the Mayor would not be required to act on it. She asked that the public recognize the special bravery of the gentlemen from Firestone Corporation who answered the distressed cries of a young girl who was being accosted. These two men successfully apprehended the man in question.

Service moved and Towell seconded a motion that Pat Murphy be recommended to the Mayor as the Council appointment to the Economic Development Commission.

The motion carried by an unanimous voice vote.
