Where the proper plan has been in effect the results are dramatic; in the first year litter decreases by 44%; the second year 50%; third year 53%; fourth year 72%. RES. 83-29 SUPPORT OF THE CLEAN CITY SYSTEM System in Indianapolis reduced their litter problem by 88%. In order to comply with the CCS program, certain requirements must be met: there must be a broad-based citizen group actively involved in the program; a litter/solid waste survey must be done; and a base line photometric plan must be determined. Once certified we will have available to us all of the materials designed to coordinate the project and also the benefits of actual field counseling. Over 300 cities are using the system at this time.

Olcott asked how the project will be funded and if additional city staff will be needed. The City has paid one-half of the application fee with Indiana Bell paying the remainder.

Kris Laughlin long involved with the project said that present team members will coordinate fund drives to raise monies and after the first year the responsibility will be with the Board of Directors to finance the program.

Olcott asked about a projected budget. Robinson said that approximately \$17-\$19,000 would be needed to finance office space and staff it properly.
