Councilmembers present: Porter, Service, Dilcher, Murphy, Olcott, Gross, Hogan. Absent: Morrison, Towell.

Council President Dilcher gave the agenda summation.

Murphy announced that the Economic Development Commission appropriated \$ 2,000 to the Clean Community System.

Service presented the winning mural selected from several submitted for the Jake's downtown wall contest. Mike Hitchcock was the artist and that particular work was chosen for its clarity, brightness and ease of execution - an important factor if the Arts Commission has to paint the mural themselves. Service also called attention to the new photographic display in the Council chambers and congratulated the organizers of the very successful 4th Street Art Fair held this past weekend in Bloomington.

Mayor Allison thanked the Economic Development Commission for their appropriation and the acknowledgment that a clean community is an important economic tool. Allison reminded the Council of the September 12 kickoff for the Clean Community System, to be held at Westbury Underground.

Olcott moved and Porter seconded a motion to introduce and read Resolution 83-33 by title only. Clerk Williams read the resolution by title only.
