In the Common Council Chambers of the Municipal Building held on January 20, 1982, with Councilpresident Pat Murphy presiding over a regular session of the Common Council

Councilmembers present: Allison, Murphy, Dilcher, Olcott Service, Hogan, Morrison, Towell, Porter.

Murphy gave the agenda summation, noting that there was a committee hearing on the items on the agenda for second reading.

Olcott announced the recent death of Hank East, long time Bloomington resident and Parks Board member.

There were no messages from the Mayor

There were no petitions or communications

President Murphy announced the appointments to the Sunset Review Committee. Members of the committee are Pat Murphy, Kathy Dilcher, Steve Hogan, Aase Loescher, and Bertina Rudman.

Towell moved and Allison seconded a motion to adopt the Sunset Review committee. All members were accepted by acclamation.

Olcott moved and Morrison seconded a motion to introduce Resolution 82-2.

Clerk Williams read Resolution 82-2 by title only.

Olcott moved and Towell seconded a motion to adopt Resolution 82-2. Dilcher read the legislative synopsis.

Resolution 82-2 was then adopted by a roll call vote of Ayes: 9, Nays 0.

Olcott moved and Towell seconded a motion to introduce Ordinance 82-2.

Clerk Williams read Ordinance 82-2 by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 82-2. Dilcher read the legislative synopsis.

Morrison asked why the downtown required preferential treatment. Allison replied that the Downtown Merchants Association hoped that the position would be filled with someone with the financial expertise to create a viable downtown.

Morrison said that there were few incentives to go downtown. Years ago Federal Revenue Fund hearings for the downtown produced three downtown merchants who expressed interest in talking with west siders.

Hogan thouroughly agreed with Morrison and stated that everything in the way of improvements always comes from the merchants own pocket. He also felt that it might be helpful to have a theme that would draw people to the area. One thing emphasized was that the Jowntown director not be just a leasing agent for the downtown.

Olcott stated that downtown Jeterioration is everywhere and that we are not going to find a brillant director for 18,000 dollars.

Service disagreed with Olcott stating that many possessors of brillant ideas do not necessarily make 50,000 dollars a year.

Pat Patterson addressed the question of funding the position of Downtown Director.
