WITHDRAWN

In the Common Council Chambers of the Municipal Building held on June 17, 1981, with Councilpresident Towell presiding over a regular session of the Common Council.

Councilmembers present: Allison, Towell, Olcott, Morrison, Murphy, Porter, Dilcher, and Service. Councilmembers absent: Hogan.

Councilpresident Towell read the agenda summation, and noted that there are requests to withdraw Resolution 81-19, Resolution 81-15 and Ordinance 81-10 from the agenda under second readings. Under first readings, Ordinance 81-63 has been withdrawn.

Allison said she attended the Housing Authority's recent open house, which she said was an excellent idea. She thanked the Housing Authority for sponsoring such an event. Second, she visited Lake Lemon's Riddle Point, and it is the only beach in the county open for swimming. Third, if citizens still have fallen limbs to be picked up after the recent tornado, they should contact the Street Department. Finally, she disagreed with Councilmember Hogan's letter to the editor in which she said he advised people to "shut up and do what Reagan wants". She stated that the American system of government is to discuss and disagree on issues and problems, noting that this is a very important part of the decision-making process.

Murphy echoed Allison's comments concerning the Street Department, and complimented them for the fine job they have been doing resurfacing in his district. Second, he said the article in the <u>Herald-Telephone</u> concerning the fire hazards at Willow Manor disturbed him, and he said he hopes the Fire Chief will examine the buildings to assure that they are safe. He said he thinks it is now time to require smoke detectors in many residential buildings. Third, he has requested that the Planning Department study the possibility of downzoning the property south of Fourteenth Street from MG to some type of residential zone.

Olcott presented an encomium for Bill Wilson, who could not be in attendance. He said he wishes Mr. Wilson well in his new position, and said it will be difficult to find a new director of Wilson's caliber.

Service agreed with Allison's remarks concerning Hogan's letter to the editor. She then commended area radio stations for the fine job they did keeping Bloomington residents informed during the recent tornado, and thanked the Street Department for their prompt action in removing fallen trees and limbs.

Towell agreed with Olcott's remarks on Bill Wilson, adding that he has had disagreements with him, but the loss to the City is real. He then addressed himself to a recent newspaper article concerning the County's decision to charge the City for dumping at the landfill. He said it is puzzling the way the County Commissioners stress that since everyone will be paying they are not being unfair to the City, but he said this constitutes double taxation on city residents who are already paying county taxes. He continued that studies have shown that 40% of the people using city parks do not reside within the city limits, and he noted that it may be time for the city to consider charging dual fees for use of city parks and other services. He concluded that the county's action is very ill advised, and the temptation is great to even things out since the county has gone back on their word.

With the state tax freeze, trying to shove problems back and forth between the city and county is not the thing to do. Second, he said the annexation ordinances are being withdrawn from the agenda since further discussion needs to take place with township and other officials, particularly concerning fire protection.

Olcott moved and Murphy seconded a motion to remove Resolution 81-19, Resolution 81-15, Ordinance 81-10, and Ordinance 81-63 from the Council agenda. Motion carried by unanimous voice vote.

Allison asked about the reports that Willow Manor may have several serious fire safety problems, and Housing Authority Gene Stokes said that he had discussed this with the Mayor and although they do not see any problems, if the Fire Department discovers violations it would then be possible to put pressure on the owners to take care of it.
