ORDINANCE 81-73 Amend Zoning 913 W. Second from RS to SM (Poolitsan)

ORDINANCE 81-74 Amend Zoning 314/318 W. 16th and 321/315 Kenwood Ave. from BG to RL (Sater, Roberts & Clark) Tim Mueller gave a presentation showing the area to be rezoned. The ordinance rezones 4 residential areas from BG to RL. This change will correct nonconforming status in all four. Mueller stated that there was some public opposition to the rezoning effort, and no one has asked that other properties be included. A neighbor on 16th & Madison said he purchased property there with a business in mind. He objected to the rezoning of the entire area, but did not object to the petitioners' singular request.

Ordinance 81-74 was then adopted by a roll call vote of Ayes: 6, Nays: 0.
