In the Common Council Chambers of the Municipal Building held on November 4, 1981, with Councilpresident Towell presiding over a regular session of the Common Council.

Councilmembers present: Allison, Towell, Olcott, Morrison, Murphy, Porter, Hogan and Dilcher. Councilmembers absent: Service.

Councilpresident Towell gave the agenda summation.

Morrison said he has a complaint about the City's Utilities Department. They spend many days digging up streets that took many years to get built, and they do a bad job of fixing the patches. He said the City Engineering Department and the Utilities Department should devise a more efficient procedure to avoid this type of problem in the future. He threatened to go to the Department of Housing and Urban Development if the problem continues.

Allison thanked the <u>Herald-Telephone</u> for their cooperation with Operation City <u>Beautiful's recycling efforts</u>. The HT has donated space for the new recycling logo to remind people to put out their newspapers the first full week of every month. She also thanked Smith Holden Music for the new planting they've put in front of their store. Finally, Allison criticized Monroe County officials for instituting a late payment penalty for users of the Monroe County Landfill. She said the county uses federal revenue sharing funds for the user fees charged to the county, yet they charge the city; it's time we were treated equally and the county stopped ignoring the half of their constituents who live in the City.

Hogan commended the City for the excellent job that is being done putting in the sidewalks on East Second Street and praised the creative work being done in the City's parks.

There was no message from the Mayor.

Murphy moved and Morrison seconded a motion to appoint James Hurd as the Council's representative from the Second District to the Traffic Commission. Motion carried by a vote of 8-0.

Brian Werth of the <u>Herald-Telephone</u> asked for the Council's reaction to the Parks and Recreation Board's request for the Legal Department to explore the legalities of closing the City's parks at night. Also, he asked if the community will have any input in this decision.

Allison said she would like to see proof that the parks are being abused before she would approve closing the parks.

Towell responded that he was firmly against the idea of closing the parks at night.

Olcott said it may be the only way for the police to control the vandalism and other destructive activities in the park. He noted that the state closes their parks at night.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 81-98 by title only.

Deputy Clerk Saperstein read Ordinance 81-98 by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-98.

Towell read the legislative synopsis, noting that there are no committee reports since the meeting was cancelled.

In response to questions, Rosehill Sexton Steve Wajda said that the fees were last increased in 1980 and that he expected this would be an annual thing.

Ordinance 81-98 was then adopted by a roll call vote of Ayes: 8, Nays: 0.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 81-97 by title only.

Deputy Clerk Saperstein read Ordinance 81-97 by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-97.

Towell read the legislative synopsis, stating that this ordinance was intended to bring the rental code into line with recent court decisions.

John Irvine, Director of Student Legal Services, said that the ordinance was needed to clarify who initiates joint inspections of rental properties.

In response to a question from Hogan it was clarified that currently the Code provides for a joint inspection within fifteen days of when the tenant moves in and after he moves out, but prior to the next tenant's occupancy. The ordinance as Towell proposed it would change these times to 48 hours and five days respectively. Towell stated that he was willing to be more lenient with these times, but he wanted to hear both Irvine's and local landlords' suggestions on it. Towell also mentioned that he had had very little input on the ordinance and that it had been distributed to the Monroe County Apartment Association.

Hogan felt there had been inadequate input from local landlords since the ordinance had not gone to committee and that it should therefore be postponed until he had that opportunity. He then moved to postpone Ordinance 81-97. Motion failed by a vote of Ayes: 1 (Hogan), Nays: 7.

Landlords Tom Barker and Bob Morris commented on the infeasibility of the proposed timetable for the check-in inspection and asked the Council to extend the period from "within 48 hours" to "within ten days".

Hogan left the meeting at this point to attend a WTIU production on Work Release .

Dilcher moved and Murphy seconded a motion to amend subsection (a) to read "ten business days" and to delete "but no longer than five days from the end of the tenant's occupancy" in subsection (b). Motion carried by a vote of Ayes: 7, Nays: 0.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-97 as amended. Motion carried by a roll call vote of Ayes: 7, Nays: 0.

Olcott moved and Morrison seconded a motion to introduce and read Resolution 81-29 by title only.

Deputy Clerk Saperstein read Resolution 81-29 by title only.

Olcott moved and Morrison seconded a motion to adopt Resolution 81-29.

Towell read the legislative synopsis, stating that this was an interlocal cooperation agreement between the Police Department and the Sheriff's Department.

Dilcher moved and Morrison seconded a motion to amend the resolution to add two new conditions in the agreement as follows: (1) That upon the sale, lease or demolition of the Jail Building by the County, the Cooperation Agreement "shall automatically terminate. (2) The City shall indemnify the County and shall agree to hold the County harmless from any liability in connection with the construction, use, or maintenance of the radio tower and it's supporting guy wire. The amendment was adopted by a vote of 7-0.
