In the Common Council Chambers of the Municipal Building held on July 10, 1980, with Councilpresident Allison presiding over a regular session of the Common Council.

Councilmembers present: Allison, Towell, Olcott, Murphy, Porter, Hogan, Dilcher and Service. Absent: Morrison.

Allison read the agenda summation.

Service said that the value of trees was realized when so many were knocked over during recent storms. She said she hopes they will be replaced.

Allison said she appreciated the <u>Herald Telephone</u>'s editorial on the importance of maintaining sidewalks. Also, a former Councilmember recently wrote an article in the Indiana <u>Daily Student</u> emphasizing the importance of walking instead of considering building new parking lots since most places in Bloomington are close enough to walk. Finally, she thanked area realtors for painting downtown fire hydrants as part of their Make America Better campaign.

There was no message from the Mayor.

There was a general consensus on the new August meeting schedule.

There were no petitions or communications.

Olcott moved and Murphy seconded a motion to introduce and read Appropriation Ordinance 80-7 by title only.

Clerk Connors read Appropriation Ordinance 80-7 by title only.

Olcott moved and Murphy seconded a motion to adopt Appropriation Ordinance 80-7.

Service read the synopsis and gave the committee report with a Do Pass recommendation of 8-0.

Appropriation Ordinance 80-7 was then adopted by a roll call vote of Ayes: 8, Nays: 0.

Olcott moved and Murphy seconded a motion to introduce and read Resolution 80-14 by title only.

Clerk Connors read Resolution 80-14 by title only.

Olcott moved and Dilcher seconded a motion to adopt Resolution 80-14.

Service read the legislative synopsis and gave the committee report with a Do Pass recommendation of 8-0.

Olcott asked if the funds could be used to buy the building and Barbara Wand, attorney with the petitioners, answered yes. She added that the whole building will be gutted with renovation of all floors. The first floor will be used for businesses and the second and third floors for offices.

Resolution 80-14 was then adopted by a roll call vote of Ayes: 8, Nays: 0.

Olcott moved and Towell seconded a motion to introduce and read Ordinance 80-55 by title only.

Clerk Connors read Ordinance 80-55 by title only.

Olcott moved and Dilcher seconded a motion to adopt Ordinance 80-55.

Service read the legislative synopsis and gave the committee report

with a Do Pass recommendation of 8-0 as amended. She then moved and Olcott seconded a motion to amend the legal description from lot two to lot one. Motion carried by a vote of 8-0.

Olcott moved and Towell seconded a motion to adopt Ordinance 80-55 as amended.

Ordinance 80-55 was then adopted by a roll call vote of Ayes: 8, Nays: 0.

Olcott moved and Dilcher seconded a motion to introduce and read Resolution 80-6 by title only.

Clerk Connors read Resolution 80-6 by title only.

Olcott moved and Dilcher seconded a motion to adopt Resolution 80-6.

Service read the synopsis and gave the committee report with a Do Pass recommendation of 7-1 (Service). She explained that she voted no because the rebate and hook-on questions were not resolved.

France Komoroske, Council Attorney, noted that hook-on provisions are not in this resolution or in Ordinance 80-26. Rebates are under Rule 7 of the resolution and in Section 10.04.040 of the ordinance.

Towell moved and Murphy seconded a motion to divide the question to separate out the provisions on rebates.

Hogan asked what would happen if the Council deleted the rebate section and Stu McClure answered that the old rebates, which are more favorable to developers, would remain in effect.

Motion carried by a vote of Ayes: 5, Nays: 3 (Porter, Hogan and Olcott).

Service said she is opposed to rebates because (1) most communities do not have them, (2) it does not make a substantial difference in whether a developer builds in or out of the city, and (3) the City is losing a lot of money with the policy at a time when funds are very tight and are needed to replace old lines.

Allison agreed that the new rules would cut back on rebates and they would be offered only to city residents.

Towell said rebates were used as security for loans to finance building projects and this was their main appeal. He said the City should encourage development in the city first, but considering the state of the economy, he doubts whether this will really encourage development.

Allison asked if the \$100,000 in the 1981 budget for sewer rebates is just for new rebates and McClure answered it is mainly for old ones, stating that there are very few rebates based on the new policy. While it will take a long time, rebate payments will be going down in the future as the old agreements are concluded.

Hogan asked who pays if the developer puts in the mains with no rebates and McClure answered that the individual would pay. The water rebate policies have been copied from state rules and then applied to sewers. Large and small developers get the same rebate.

Olcott contended that the more people that hook onto the system, the more the cost will be spread out although most of the savings would be over a long period of time. RESOLUTION 80-6 To Approve Rules & Regs for Blgtn. Wastewater Utility Common Council Minutes July 10, 1980 Page three

Towell moved to approve Rule 7 concerning rebates and Dilcher seconded the motion. Motion carried by vote of Ayes: 6, Nays: 2 (Service and Allison).

After general discussion concerning hook-ons, the Council recommended that the Utilities Service Board come up with a hook-on charge at the same time the new rate package is presented. Motion carried by a vote of 8-0.

Resolution 80-6 was then adopted by a roll call vote of Ayes: 7, Nays: 1 (Service).

Hogan commented that perhaps a grace period would be in order with the hook-on fees to ease the financial burden, and Allison agreed.

Olcott moved and Dilcher seconded a motion to introduce and read Ordinance 80-26 by title only.

Clerk Connors read Ordinance 80-26 by title only.

Olcott moved and Dilcher seconded a motion to adopt Ordinance 80-26.

Service read the synopsis and gave the committee report with a Do Pass recommendation of 7+1 (Service).

Ordinance 80-26 was then adopted by a vote of Ayes: 7, Nays: 1 (Service). Service commented that she thinks that people should be required to hook on sooner than in three years and suggested one year or six months. Allison said she would go along with not more than three years and Olcott said six months is too soon for some people to handle financially since it could cost \$3,000 per residence in some cases.

Olcott moved and Dilcher seconded a motion to introduce and read Ordinance 80-13 by title only.

Clerk Connors read Ordinance 80-13 by title only.

Olcott moved and Hogan seconded a motion to adopt Ordinance 80-13. Service read the synopsis and noted that the Council had referred this ordinance back to the Traffic Commission for their recommendation, and the T.C. has now recommended approval.

Roger Branam, Street Superintendent and Traffic Commission member, said that the reasons for no parking on both sides is that there are three lanes of traffic and there is absolutely no place to park.

Dilcher moved and Towell seconded a motion to amend the ordinance as requested to have no parking on both sides of the street. Motion carried by a vote of 8-0.

After discussion concerning the unusually long length of the 600 block, Olcott moved and Dilcher seconded a motion to adopt Ordinance 80-13 as amended. Motion carried by a vote of 8-0.

Olcott moved and Dilcher seconded a motion to introduce and read Ordinance 80-58 by title only.

Clerk Connors read Ordinance 80-58 by title only and Allison read the legislative synopsis.

Olcott moved and Dilcher seconded a motion to introduce and read Ordinance 80-59 by title only.
