The Common Council of the City of Bloomington met in regular session on May 3, 1979, in the Common Council Chambers in the Municipal Building and conducted the following business:

These minutes are a summary - a taped recording is on file in the City Clerk's office.

ROLL CALL

PRESENT: Morrison, Towell, Kinzer, Richardson, Olcott, Blume, Allison

AESENT: None (Young and Middleton arrived late)

There being seven (7) members present and two (2) members absent and seven members representing a quorum the session was officially opened by Councilpresident Allison.

AGENDA SUMMATION

Councilpresident Allison read the Agenda.

MESSAGES FROM COUNCILMEMBERS

Councilmember Blume said he attended a neighborhood meeting and they were concerned about the lack of sidewalks at High Street and Second Street. Blume said he did not think this could wait until the budget meeting to be acted on by Council.

Councilmember Olcott said he would like to see the city upgrade Miller Drive. He added that he hoped everyone would vote Tuesday May 8th.

Councilmember Richardson said he was also concerned about the lack of sidewalks on High Street and hoped the Council would look into it.

Richardson said he thought the city needed some kind of overpass or underpass but that he was not convinced the proposed E.W. corridor on Third Street was the answer. He added that it would have an unfavorable impact in the neighborhood.

Richardson then congratulated Joe Norman for being selected by the Seattle Sea Hawks and then reminded everyone 16 yrs. or older to sign up for Adult Soccer.

Councilmember Towell said that the area around Griffy Reservoir has been badly damaged and neglected for a couple of years. Towell said he hoped Councilmembers would drive out and look at the situation.

Councilmember Morrison mentioned the new face lift on the West Side because of the re-building of North Monroe Street and also the storm sewer project for Jackson Street and Maple Street.

Councilpresident Allison said there were 3 particular areas that are potentially dangerous to children because of lack of sidewalks. She said these areas are on Hillside Street, High Street, and the Bypass at Tenth Street. Allison said these dangerous areas must have some solution.

Councilmember Towell said about eight years ago a sidewalk task force did a study and mapped out high priority areas. He said High Street was top priority in the study and some sidewalks were put in.

Councilpresident Allison said maybe the study could be re-activated.

Councilmember Blume said he felt an E.W. corridor on the South Side of town around TappRoad to Winslow was needed. But he said we still need an E.W. corridor on Third Street to keep the traffic on the thoroughfares,

He said in addition to 102 employees for the community it brings into the community retired persons who bring a good deal of wealth to the community to be expended within the community.

Councilmember Kinzer said she would prefer to see a permanent solution.

Councilpresident Allison said putting a pitch on the building would be a major reconstruction.

Councilmember Blume said he did not think anyone should vote against the ordinance because the roof is already flat.

Committee Chairman Towell read the legislative synopsis and gave the committee report of a Do Pass recommendation. Towell said the committee had a lengthy discussion and although everyone agreed it was a compromise he said he thought it was a successful compromise because the committee voted 8-0.

Councilmember Richardson said the votes were simply not there to strike the deposit requirements.

Councilmember Richardson moved and Councilmember Towell seconded the motion to strike Rule 10 A and B and subsections on pages 12 and 13 of the rules and regulations.

Richardson said this motion does not strike all deposits because those people who have proven themselves irresponsible can still be required to pay a deposit.

Councilmember Kinzer said the requirement for deposits cuts down substantially delinquent payments. She said the rules give people time to pay their deposits and is a fair requirement. Kinzer added that the statistics show that deposits are needed.

Councilmember Towell said in the past the Utilities Department did not have the means to send notices to remind people of payments past due so he would question the statistics.

Councilmember Blume complimented the Utilities Service Board, Stu McClure and everyone who had worked on the utilities document. He then asked the Council not to support Councilmember Richardson's motion.
