The Common Council of the City of Bloomington met in regular session on June 7, 1979, in the Common Council Chambers in the Municipal Building and conducted the following business:

These minutes are a summary - a taped recording is on file in the City Clerk's Office.

ROLL CALL

PRESENT: Morrison, Towell, Young, Olcott, Blume, Allison ABSENT: Kinzer, Richardson, Middleton

There being six (6) members present and three (3) members absent and six (6) members representing a quorum the session was officially opened by Councilpresident Allison.

AGENDA SUMMATION

Councilpresident Allison read the Agenda.

MESSAGES FROM COUNCILMEMBERS

Councilmember Olcott mentioned the success of the Hoosier Hills Festival and asked that people support the remainder of activities.

Councilmember Morrison complimented the city for the work done on the Rose Hill Cemetery. He said many people had stopped at his store to to compliment the city for the attractive condition of the cemetery.

Councilmember Blume said we can thank Jim Wray for that.

Councilpresident Allison congratulated Herald-Telephone reporter Mike Wright on his plans for marriage.

Allison congratulated Phyllis Trinkle on her promotion to Director of the Community Action Program.

Allison then thanked the Chamber of Commerce for flying some of the Councilmembers to Madison, Wisconsin to see the renovations being done in their downtown area.

MESSAGES FROM THE MAYOR

There were no messages from the Mayor.

PETITIONS AND COMMUNICATIONS

Councilmember Towell explained that some members of Council took a walking tour around Griffy Lake and saw a lot of destruction created by off the road vehicles. He said the Parks and Recreation Department put up posts and signs to keep traffic off the emergency routes and out of the woods but some of the posts have already been torn down. Towell then introduced Peter Gold and Lee Nading who were present to give a slide presentation on the Griffy Lake area.

Lee Nading said Griffy was one of his and Peter's favorite hiking areas and last October they decided to take slides of the destruction happening around Griffy Lake. Nading said they also took slides two weeks ago to show how much destruction has happened since October. He pointed out the knee high ruts on the emergency roads, erosion of soil around roots of trees as a result of high travel on the roads and destruction to trees because of vehicles running into them.

Dick Martin came before the Council and introduced himself as a resident of ten years next to Griffy. He said during that course of time he organized many clean-up crews to pick up trash around the lake. Martin said there has been no attempt on the part of the city to do any maintenance. He said there are as many as 200 people on any given weekend on or around the lake. Martin said the attitude of the people

who use the area must be changed because it is used as a hang-out.

Martin said people build fires in the woods and steal from the cars. He said the State Conservation office received thirteen complaints on Griffy just last week.

Councilpresident Allison said she thinks there should be more enforcement of the law when they catch people plus an effort to block emergency routes for unauthorized vehicles.

Councilmember Olcott said they will probably have to fence off the roads.

Councilpresident Allison said they should have some decisions made by the next council meeting on what actions they will take with Griffy problems.
