Councilman Clegg moved that proposed Ordinance No. 69-35 be adopted. Councilman Morrison seconded the motion. Roll call vote: ayes 8, nays 0.

Councilman Clegg moved that proposed Ordinance No. 69-34 be introduced and be read by the Clerk. Councilman Morrison seconded the motion.

The Clerk read proposed Ordinance No. 69-34.

President Faris explained that it is not normal procedure to have discussion at first reading of an ordinance but since so many had taken the trouble to attend the meeting, time would be allowed for a short discussion.

David McCrea, Attorney for the Miller Drive Neighborhood Association, spoke briefly on the conditions in the area.

Mr. Hardy, President of the Miller Drive Group, Mr. Thorne, Mr. Rush and Mr. Todd, residents of the area, each spoke briefly but in favor of the annexation.

Dr. Ray Borland, Monroe County Health Officer, spoke in favor of the annexation saying that health regulations could be more easily enforced if the area were inside the City and his actions could be supported by the codes and ordinances of the City.

Mayor Hooker said the Council and the City Administration was very much in favor of this proposed annexation. He said, however, that to provide a full complement of city services to the area would take time, it will cost money and the Administration cannot perform miracles. Mayor Hooker said the Common Council and all the Boards and Commissions would do their very best to provide the necessary services we have within the City and would provide them in the most economical and efficient manner as rapidly as possible.

Mayor Hooker said that when and if the proposed annexation ordinance is passed, the residents of the area could expect the following:

- 1. Full police protection immediately.
- 2. Full fire protection immediately.
- 3. Full rights and privileges to Rose Hill Cemetary.
- 4. Full rights and privileges to Parks and Recreation facilities.
- Immediately and to the best of our ability street cleaning and snow and ice removal. When it comes to improvements, street funds are limited.
- Street name signs and traffic control signs will be installed before the first of the year.
- 7. No firm commitment can be given regarding the installation of street lights but the area definitely will be included in the street lighting program.
- Trash and garbage pickup investigation will have to be made to see if we have the money to add the area to the routes this year.

- 9. Code enforcement This Administration and Common Council have upgraded ordinances and added needed ones. It is possible that a few buildings in the Miller Drive area will have to be condemned and removed.
- 10. It is many times difficult to say which is more important sewers or water. This Administration has put water first but sewers can not be far behind. At the very earliest, it would be two years before the City could promise water and sewers to the area. However, the owners of property in the area could initiate a program, similar to the Barrett Law program. and pay for the instal-
 - Barrett Law program, and pay for the installation of sewers. It is possible that the City, two years from now, could have some money to work together with the residents of the area. The City would look into Federal programs that would apply.
- 11. Water needs fall into the same category as sewer needs. When the area does come into the City, we would try to have it certified as a Neighborhood Program. If we could do so there would be a possibility of sanitary and storm sewers, sidewalks, street improvements and water service. We will do our very best to see if we can qualify this for a type of program to help the people help themselves.

Mayor Hooker said the City is concerned about these things but it needs to have concern for the people involved also. He commended Reverend Hardy and Attorney McCrea for their efforts in behalf of the area.

Councilman Harry Day asked the Clerk to read proposed Resolution No. 69-13 and moved its adoption.

The Clerk read Resolution No. 69-13.

Councilman Clegg seconded Councilman Day's motion and it carried by an unanimous voice vote.

President Faris asked the Clerk to see that copies of the resolution were sent to all players and coaches.
