Councilman Madden asked why this was necessary. Council President Faris explained that the existing committees were set up when Bloomington was a third class city. Councilman Clegg said the chairmen and their committees could function better if the load was spread out a little bit.

Dr. William Hammer, Bloomington Hospital X-ray technician, said he was representing the Chamber of Commerce in asking the aid of the Council and the Administration in trying to get some flowering trees planted in the City. He asked for help to be given in furnishing guide lines for operation and in getting the merchants to plant trees.

Councilman Fee suggested that Councilman Day be asked to meet with the committee and work with them as Council representative to the Chamber of Commerce.

Mayor Hooker cited the several hundred trees that had been planted as a result of the interest of the Council and the Administration in this project. He mentioned the different local industries that had taken an active interest in landscaping their grounds and said he would encourage all people to participate in a project of this kind.

Dr. Jerome R. Mintz, of the Indiana University Folklore Institute, asked that the Council give consideration to enacting an ordinance that would provide law enforcement for public safety in the private parking lots in Bloomington. He suggested they be laid out more like the lots at Indiana University.

Councilman Maddon concurred and suggested that the President of the Retailers Association be contacted.

Mayor Hooker also concurred and suggested that the Council investigate the control of the development of parking lots in shopping centers. He asked Fire Chief Miller to comment on parking lot layouts in the South. Chief Miller said he had paid particular attention to this situation on a recent trip to the southern states and that the emphasis there was on public safety.

Miss Laura Campbell asked that something be done to alleviate double parking and parking on the sidewalk at the apartment house at Second and Dunn Streets. She said that while off-street parking had been provided, ingress as well as ogress was through a narrow city-owned alley. Councilman Clendening suggested that many people did not use the off-street parking facilities because of the extra fee imposed for parking there.

REPORTS FROM CITY OFFICIALS AND DEPARTMENT HEADS

Councilman Clegg personally commended James D. Sargent, MESSAGES FROM COUNCILMEN Street Commissioner, and his personnel and Mayor Hooker for his advance planning in the handling of snow and ice control during the recent storms. Council President Faris agreed and said he thought the Utilities and Fire Departments should be commended also for their cooperation.

Mayor Hooker said he wished to thank the citizens of MESSAGES FROM MAYOR Bloomington for driving safely and keeping the accident rate at a minimum.

Mayor Hooker said we are privileged to live in such a dynamic community but nothing is so perfect that it can not be made better. He suggested that attention be given to the following:

- 1. The area of public safety
- 2. Traffic control enforcement
- Fire code-areas used by the public, especially multiple housing.
- 4. Improvement in street conditions
- 5. Improvement in street lighting

In the long range area, Mr. Hooker suggested:

- 1. More adequate and desirable facilities for public safety in complex situations such as shopping centers, etc.
- 2. Reclassification of present insurance rating for the city, with hopes for a higher rating.
- 3. Up-dating of the city master plan.
- 4. Acquisition of a qualified Director of Planning.
- 5. Establish a City-County Building Authority
- 6. Multi-level parking facilities for the downtown area
- 7. Recreational facilities for the post-high school group and for the senior citizens
- g. Continuation of Engineering Department work on a storm sewer program
- 9. Encourage influx of research and development groups to give a broader face to our economic growth
- 10. Work with Indiana University on the Aero-space program
