action needed now is for the City Council to give permission to the City Plan Commission to initiate formal action to the Board of County Commissioners and they will respond by enacting an Ordinance. Under this Two Mile Plan jurisdiction we hope to have a master plan for the development of the city. It is only logical that the City will continue growing. Either through the City action or voluntary annexation, we can have public thoroughfare development, parks, fire protection, sanitation. It is highly desirable to have supervision for an area prior to their incorporation. Mayor Hooker told the group that after the County has enacted the Ordinance, assigning the area to the City, the area will automatically become zoned R-1. The City then will have developed a master plan covering this two mile area. Mayor Hooker suggested that the City of BLoomington would, at the same time, have a new overall master plan developed for the City, which would include this two mile jurisdiction. Mayor Hooker strongly recommended to the Common Council that it would enact a resolution, and going on record as being in favor of the exercise and supervision over the two mile area and requesting the Plan Commission to adopt a petition to the County Board of Commissioners requesting that they officially assign jurisdiction to the City of Bloomington. Mayor Hooker also told the audience that he had been giving some thought to and would suggest there be created an adivsory corporation (it could be called "The Greater Bloomington - Monroe County Planning Council") Louisville, Jeffersonville and New Albany have initiated a group such as this among themselves. Mayor Hooker feels since there is always overlapping authority, a group such as this would be one of the best ways to handle it. The Mayor suggested there might be three representatives from the city, The Mayor, Common Council member, also a County Council Plan Commission members, Also the President of the metropolitan schools of Bloomington as well as the President of the County School Board. A representative of T.U. might also be included. Mayor Hooker also recommended a re-presentative of the Federal of Labor, Chamber of

Councilman Fee moved that proposed Resolution No. 67-12 be adopted. Councilman Johnson seconded the motion and it carried unanimously.

Commerce and League of Women Voters..

Councilman Fee recommended at this time, that the Mayor look into any available information on the Houston Planning Association. Houston has no zoning, they simply have an association.

In answer to Councilman Harry Day's question about organizational structure of the "Planning Council" Mayor Hooker said that this Council would be on a voluntary basis only. Hopefully, it would bring forth a more constructive attitude and a spirit of working together toward a common goal.

Council President introduced to the audience Mr. Robert Branum, Jack Morrison, Dr. Robert Gray who are nominees for Council.

Mr. Femal, Director, Parks and Recreation reported that the projects are coming along very well, although the rain has held them up somewhat. They are progressing and the park areas are looking nice. Mr. Femal reported that the golf courses are being played more than any other season at this same time.

Councilman Harry Day reminded the group that along Walnut and College there were many places which could be places of beautification or they could be eye sores. Councilman Day urged peopled to use their imagination, because the tree plots were very valuable and these places could be beautified.

Mr. Cotner reported to the audience in regard to the previous Council meeting and the situation of D-X. Mr. Cotner learned that D-X are proceeding with the construction of the station and are planning to cut the curb. Mr. Cotner reported that he had filed suit against D-X Company that morning, asking for injunction to prevent them from doing this. Mr. Cotner said that the City alledged the cutting of the curb: 1) if it were cut it would create a traffic hazard 2) if it were cut and had to be replaced, the City would just have a patched curb. Mr. Cotner also said that until the Court takes action the company could go ahead and cut the curb and the Court could make them put it back in. The return date is 19th of May. There will be a hearing then.
