As of May 1, 1962, our present schedule will be changed as follows: Our regular schedules will remain the same except that our busses will discontinue all service at 8:00 P.M. instead of 10:00 P.M. which is now in effect. Friday will be the only exception, and because of a heavier shopping day by the public which demands later service, we will continue service until 10:00 P.M. on this one day only. Sunday transportation will be discontinued altogether.

As was mentioned, we will advertise this change in the newspaper for a suitable length of time so that what few people are using our night service can make other arrangements.

This is not an impulsive move on our part. For several months we have surveyed our night traffic and the amount of passengers using it does not warrant confinued service. Averaging our passenger receipts for these hours shows the revealing fact that we are barely paying our drivers wages. It is costing us in addition fuel used, tire wear and general wear on the busses.

Any discontinuence of our service is not to our liking and very regretable. Under the circumstances we don't feel the city or the public in general would expect us to kepp operating a schedule at a deficit. We appreciate your consideration and help in this matter, and trust that the changes will meet with your approval.

Mr. Bayne, Manager of the Bloomington Leppert Bus Lines, Inc. discussed these changes with the Council. Councilman Chitwood suggested that the Leppert Bus Lines try to work out a schedule that would take care of the peopledesiring to go to church on Sunday morning. Mr. Baynes informed the Council that he would work with Mr. Fry and try to keep the busses running for this purpose. He also informed the Council that publicity would be given to the changes by newspapers and radio.
