Councilman Sikes moved, seconded by Councilman Chitwood that Appropriation Ordinance No. 3, 1957, be duly adopted as amended by reducing Personal Services of the City Court in the amount of \$680.00; motion unanimously carried.

Appropriation Ordinance No. 3, 1957 was duly adopted.

Councilman Sikes moved, seconded by Councilman Simpson that the Common Council take up other matters of business to be transacted at this special statutory meeting. Upon a roll call vote the motion was unanimously carried.

Councilman Van Meter, moved, seconded by Councilman Simpson that the resignation of Councilman Roy R. Cook be accepted and a letter be directed to Councilmen Cook thanking him for his services to the City of Bloomington; motion unanimously carried.

Councilman Sikes moved, seconded by Councilman Simpson that the Council meet on September 3, 1957, at 7:00 P.N. D.S.T. for the purpose of selecting a successor to Councilman Cook due to said Councilmen's resignation; motion unanimously carried.

Councilman Miller moved, seconded by Councilman Chitwood that the Council adjourn; motion unanimously carried.
