REGULAR MEETING

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in regular session in the Council Chamber at the City Hall, Bloomington, Indiana, September 2, 1952, at the hour of six-thirty (6:30) P.M., with Mayor Kelly presiding.

The minutes of the regular meeting August 19, 1952, were approved by the Council upon motion of Councilman Fowler, seconded by Councilman Miller.

The minutes of the special statuatory meeting August 25, 1952, were approved by the Council on motion of Councilman Miller, seconded by Councilman McDaniel.

A request was received from Mrs. Gurnie Hopper for permission to cut the curb at her residence at 333 South Henderson Street to provide driveway entrance. Councilman Fowler reported for the Committee on Streets, Alleys, and Bridges, that the Committee had already investigated this request and recommanded that permission be granted. Mr. Fowler moved that the petition be granted as requested with the work to be done under the supervision of the City Engineer; Councilman Porter seconded the motion; motion carried.

A petition was received from William C. Evers, Jr., for permission to extend the cut of curb at his address, 802 East Hunter Avenue, to provide better entrance to driveway. Councilman Fowler advised that the Committee on Streets, Alleys, and Bridges, had already investigated this request, and recommended that permission be granted. Mr. Fowler moved that permission be granted with the work to be done under the supervision of the City Engineer and according to the Engineer's specifications; Councilman Griffith seconded the motion; motion carried.

A letter was received from Marvard A. Clark, Secretary of the Plan Commission, reporting on the action of the Plan Commission in regard to the request for rezoning of Lots Nos. 18, 19, and 20, of Kenwood Park Addition. A Resolution No. 3, 1952, of The Plan Commission was enclosed, approving the rezoning of the lots from B-3 General Business Zone to R-1 One Family Zone. Ordinance No. $7\frac{1}{2}$, 1952, to amend the Bloomington Zoning Map dated July 18, 1950, was presented to the Council, changing the zoning on said Lots Nos. 18, 19, and 20, Kenwood Park Addition, from B-3 General Business to R-1 One Family. Councilman Fowler moved for suspension of rules so that the Ordinance might be voted on at this meeting; Councilman McDaniel seconded the motion; motion carried. Councilman Miller moved the adoption of Ordinance No. $7\frac{1}{2}$, 1952, amending the Bloomington Zoning Map dated July 18, 1950; Councilman McDaniel seconded the motion; Mayor Kelly requested a roll call vote, and the remponse was as follows: Ayes: Carpenter, Fowler, Griffith, McDaniel, Miller, and Porter; Mays: none; Absent: Ramsey; motion carried , and the Ordinance officially adopted.

The report of Fire Chief Horace Robertson for the month of August 1952 was presented to the Council, and accepted on motion of Councilman Carpenter, seconded by Councilman Porter.

Councilman Miller reported for the Committee on Sidewalks and Street Lighting in connection with the request for installation of a street light at the intersection of First Street and Mitchell Street, and recommended that the installation of the light be approved. Mr. Miller moved that the Council approve the installation of street light at the intersection of First and Mitchell Streets; Councilman Griffith seconded the motion; motion carried.

The meeting adjourned on motion of Councilman Fowler, seconded by Councilman Miller.
