The minutes of the last regular meeting were read and approved as read upon motion by Councilman Chitwood, seconded by Councilman Dunn and carried.

## PETITIONS:

ACAOUS

A Petition from Richard E. McGuire at 1008 E. Seventeenth Street was read, requesting a street light at the intersection of 17th Street and Walnut Grove.

Councilman Chitwood moved the above petition be referred to the Light Committee and they are to report back at next Council meeting. Seconded by Councilman Sikes, motion carried.

The Clerk-Treasurer presented an application for Taxi License from Wm. Wayne and Alice Wampler, d/b/a I. U. Cab Company, for the Council's consideration.

Councilman Dunn moved this application be granted after the insurance is corrected to correspond with said application. Seconded by Councilman Chitwood, motion carried.

Councilman Sikes moved the Recreation Department be commended for excellent report and ordered it to be placed on file in the Dlerk-Treasurer's office. Seconded by Councilwoman Woolery, motion carried.
