

## REGULAR MEETING

TUESDAY, AUGUST 15, 1950.

The COMMON COUNCIL met in regular session at 6:30 P. M., CST., on Tuesday, August 15, 1950 in the Council Chamber with Mayor Lemon presiding.

Roll Call - Present: Black, Chitwood, Dunn, Parks,  
Shank, Sikes, Woolery  
Absent: None

The minutes of the last regular meeting were read and approved as read upon motion by Councilwoman Woolery, seconded by Councilman Black and carried.

PETITIONS:

Petition was received from George and Peter Costas requesting permission to cut sidewalk at the premises at 522 E. Kirkwood Ave. for drainage purposes. Motion was made by Councilman Shank, seconded by Councilman Dunn, that their request be granted provided all work is done under the supervision of the City Engineer. Motion carried.

A letter from the Commander of Burton Woolery Post 18 was read by the Clerk-Treasurer, recommending to the Council that electric lights for the runways be added to the facilities at Kisters Field. Councilman Chitwood moved that the letter be placed on file in the Clerk's office. Seconded by Councilwoman Woolery, motion carried.

MONTHLY REPORTS:

Street Commissioner Glenn Marlin submitted the monthly report for the Street Department. Motion was made by Councilman Black that the report be accepted and placed on file in the Clerk's office. Seconded by Councilman Shank, motion carried.

Councilman Shank moved that the petitions which were received at the Council meeting held on August 1, 1950 from Anne C. Curry requesting permission to cut curb and sidewalk at 413 S. Washington St. and from A. J. Fluck, requesting permission to cut curb and sidewalk on E. Ninth St. between Walnut and College Sts. be granted with the provision that all work will be done under the supervision of the City Engineer. Seconded by Councilman Parks, motion carried.

The Light Committee investigated the lighting on West Cottage Grove and Adams Street. Motion was made by Councilman Chitwood, seconded by Councilman Shank that the petition submitted to the Council at a previous meeting requesting that a street light be placed on the above location be granted. Motion carried.

Councilman Dunn made a motion that rent be decontrolled in the City of Bloomington, Indiana, according to Federal Rules and Regulations, and that a Resolution be introduced and adopted before the meeting is adjourned; motion seconded by Councilman Shank. Upon roll call vote, the vote was as follows: Black, aye; Chitwood, aye; Dunn, aye; Parks, naye; Shank, naye; Sikes, aye; Woolery, aye. Motion carried by 5 to 2 vote.

Upon motion made by Councilman Black, seconded by Councilman Chitwood and carried, claims Nos. 2269 to 2440, inclusive were approved, and warrants in the total amount of \$47,651.06 ordered issued.

Upon motion made by Councilwoman Woolery, seconded by Councilman Sikes and carried, the meeting is hereby recessed until 6:30, P.M., CST. on Monday, August 28, 1950.
