The Bloomington Board of Public Safety held a Regular Session on **Tuesday**, **July 21st**, **2020**, **at 6:00 p.m.**, Teleconference/Virtual Meeting.

#### CALL TO ORDER

Board member Luis Fuentes-Rohwer called the meeting to order at approximately 6:02 p.m.. Other Board members present were: Maqubé Reese and Rafi Hasan.

The only member of the public in attendance was Laura Lane.

#### **MOMENT OF SILENCE**

Board member Maqubé Reese made a request for a moment of silence for victims of COVID-19 and racial violence.

Board member Rafi Hasan also wanted to recognize first responders as well.

#### APPROVAL OF MINUTES

Board members unanimously approved the minutes from June 23, 2020 through a roll-call vote by board recording secretary, Nikki Mosier. The motion was made by board member Rafi Hasan and seconded by Maqubé Reese.

#### FIRE DEPARTMENT BUSINESS

Report on Monthly Statistics, Training and Incident Reports:

Fire Chief Jason Moore gave a report on the monthly statistics.

Board member Rafi Hasan inquired about an adjustment to the budget that Fire Chief Jason Moore mentioned. Fire Chief Jason Moore answered the question.

Letters of Appreciation and Commendation:

Fire Chief Jason Moore said that there were none.

Report on Monthly Statistics, Training and Incident Reports:

Deputy Chief Joseph Qualters presented on the monthly statistics.

Board member Rafi Hasan stated that MCCSC benefited from three police officers who participated in the district's real talk critical discussion.

Board member Luis Fuentes-Rohwer inquired about a case of a man who covered himself in lighterfluid. He said that his first thought was why are police being called for that.

Police Chief Mike Diekhoff answered the question. He spoke extensively about police responding to things because they do not know who else to call.

Board member Luis Fuentes-Rohwer stated he was happy to hear from Centerstone at the last meeting. He then inquired about what mental health training officers are given.

Police Chief Mike Diekhoff answered the question. He stated that they do a lot of training on deescalation and mental health.

Board member Maqubé Reese inquired about the Stride Center for crisis diversion and receiving stats.

Police Chief Mike Diekhoff answered the question.

Board member Rafi Hasan made a statement about data collection.

Board member Maqubé Reese made a statement about people being concerned about submitting bias reports.

#### Letters of Appreciation and Commendation:

Deputy Chief Joseph Qualters said there were six letters of appreciation. He provided some information about the letters.

Board member Luis Fuentes-Rohwer inquired about an incident that was mentioned in a letter. The incident took place in mid-June.

Deputy Chief Joseph Qualters provided that information.

<u>General Business: Request for Approval of MOU with City of Bloomington Utilities for Demolition of</u> <u>Incinerator Building:</u> Assistant City Attorney Chris Wheeler provided information about the request.

Board member Luis Fuentes-Rohwer inquired about the need to come back for additional approval.

Assistant City Attorney Chris Wheeler answered the question.

Board member Rafi Hasan inquired about whether a contractor had been determined yet:

Assistant City Attorney Chris Wheeler answered the question.

Board members unanimously approved the MOU as written. Board member Maqubé Reese made the motion, and board member Rafi Hasan seconded the motion.

# General Business:

Police Chief Michael Diekhoff presented the "8 Can't Wait" and "21<sup>st</sup> Centry Policing" initiatives. He highlighted the ban on choke holds. He said those have been banned by the department. He then highlighted the de-escalation training requirement, which he said the department has extensive de-escalation training. He added that every training has de-escalation training within it.

He then highlighted the requirement for warning before shooting. He said the department's use of force policy requires an officer give verbal warning before deadly force whenever it is feasible to do so.

He said number four on the "8 Can't Wait" demands is to exhaust all alternatives before shooting. He once again said that it is within the use of force policy for the department.

He then mentioned number five on the demands list which is a duty to intervene. He said that rules and regulations require it. He then said number six is the shooting at moving vehicles. He said that one has not been completely banned. He said that officers have a lot that they have to evaluate before making that decision.

He then said number seven is to establish a use of force continuum. He said that all use of force must be reported.

Board member Luis Fuentes-Rohwer inquired about the process they will be using to review.

Police Chief Michael Diekhoff answered the question.

Police Chief Michael Diekhoff then went into more detail to review the policies.

Board member Rafi Hasan inquired for clarification.

Police Chief Michael Diekhoff answered the question.

Board member Maqubé Reese inquired about a recent incident and accountability.

Police Chief Michael Diekhoff answered the question. He said the incident did not include the Bloomington Police Department.

Board member Maqubé Reese inquired about the mental health of officers and how they are checked in on.

Police Chief Michael Diekhoff answered the question.

Police Chief Michael Diekhoff said there might be some final bills for the completion of the storage facility. He also said there might be something for purchasing new vehicles for the department.

#### Personnel: Promotion of Officer Ryan Tibbs to Senior Police Officer

Deputy Chief Joseph Qualters presented Officer Tibbs' credentials.

Board members unanimously approved the promotion of Ryan Tibbs to Senior Police Officer, effective July 13, 2020. Board member Rafi Hasan made the motion, and board member Maqubé Reese seconded the motion.

Dear Chief Diekhoff,

Deputy Prosecutor Chris Pierce and I want to reach out to commend Officer Paul Post, as well as other officers who responded to the incident with Ernest Wright on July 25, 2020. When Officer Post came into contact with Mr. Wright, Mr. Wright immediately drew a knife. Officer Post had the presence of mind to put some distance and his car between Mr. Wright and himself and call for assistance with less lethal options. This easily could have been a police-involved shooting, but fortunately, that is not the case. When Officer Drew Bazan joined Officer Post, Mr. Wright continue to wield his knife, and Officer Bazan showed similar restraint. Officer Amy Romoser and Officer Post used less lethal means to disarm Mr. Wright. Other officers involved include Jeff Rees, Brandon Deckard, Zach Weisheit, and Mick Williams.

I know that some have suggested that a social worker should have responded to this incident. Realistically, an unarmed social worker would be unable to confront someone armed with a knife, and likely, police would have been called to assist in that event as well.

We continue to be impressed with the Bloomington Police Department's policy, training, and other initiatives. However, I am particularly proud of Officer Post and the others who were able to calmly assess a dangerous, dynamic situation and respond appropriately. It is my sincere hope that BPD continues to recruit and retain people who serve and protect our community so well.
