- I. Call to Order- (~5:34 PM)
- **II. Approval of Minutes July 9, 2020**-- Binder motioned to approve the minutes and Volan seconded the motion. The motion received a roll call vote of Ayes: 6, Nays: 0, Abstain: 0; the motion passed.
- III. Reports from Commissioners & City Offices Michelle Wahl talked about the online parking permit sales for residential neighborhood zones.

#### IV. Reports from the Public - none

The Commissioners decided to discuss the Resolutions first and then the Discussions of Topics Not the Subject of Resolutions. Evans Fernandez motioned to approve the recommendation and Binder seconded the motion. The motion received a roll call vote of Ayes: 6, Nays: 0, Abstain: 0; the motion

passed.

#### V. Resolutions

#### A. Parking Resolution 20-01 -- Title 15 Amendments

Volan motioned that the resolution be presented and Binder seconded the motion.

Kaboli Farshchi, presented for staff, the Title 15 Amendments.

Discussion: parking restrictions and assigned parking spaces for motorcycles and mopeds; previous actions of Parking Commission; pay by phone zones; loading ones; no parking zones

Evans Fernandez motioned to approve the staff recommendation to be forwarded to the Common Council for their consideration, Ion seconded the motion. The motion received a roll call vote of Ayes: 6, Nays: 0, Abstain: 0; the motion passed.

#### B. Parking Resolution 20-04 (revised) – establishing a Parking Benefit District in Neighborhood Zone 6

Volan motioned that the resolution be presented and Binder seconded the motion.

Volan presented the resolution and explained his Parking Benefit District proposal for the Neighborhood Parking Zone 6 (Garden Hill) and the revisions.

Discussion: price; demand; eligible people for permits; Zone 6 background; permit limits; subsidized prices; renters; home owners; students; types of the improvements project in the zones and decision making process; market price; fairness; neighborhood association; other types of permits in the Zone 6; sidewalks; quality; new temporary visitor parking permit impacts; pilot project; game days; implementation process; timing; pandemic; demand; online permit sales; required resources; implementation date; data resources; preparation process

Evans Fernandez motioned to approve the recommendation and Volan seconded the motion. The motion received a roll call vote of Ayes: 3 (Evans Fernandez, Ion, Volan), Nays: 3 (Binder, Gates, Robinson), Abstain: 0; the motion failed.
