2021 Parking Commission Process for Petitions

Process

All persons seeking approval for a parking request are encouraged to contact the City Planning and Transportation Department as early as possible to schedule a pre-petition meeting. This meeting is required and must occur by the deadline listed in this schedule.

Following the pre-petition meeting with Planning and Transportation staff, the petition will be reviewed. Once a petition has been filed, the deadline for submitting any revisions or additional information to staff is one week prior to the Parking Commission packet distribution, or as specifically noted in this schedule.

Please schedule petition filing meetings with the case manager 48 hours prior to the filing date. Regular Parking Commission meetings generally take place on the 4th Thursday of each month, from 5:30 pm to 7:00 pm, in the City Hall Hooker Conference Room (#245) or virtually on Zoom unless otherwise announced.
