## CALL TO ORDER

## CRIME IN PERSPECTIVE

- The overall NIBRS crime for the city of Bloomington decreased by 6.7% in 2020.
- Despite increases in Homicides, overall crimes against persons decreased by 19.6%. It is important to note that most crime is not random.
- Crimes against Property had an overall increase of 4.7%. This was due to an increase in Theft, Burglary and Vehicle Theft.



## **TRAINING**

- The Training Division conducted over 8943 Hours of in-service training in 2020, over 3.5 times what is required by the State of Indiana
- Numerous training programs including crime prevention, active violence and others were provided for our community partners including businesses, schools and other governmental agencies

## **BPD TRAINING 2021**

Listed below is training that is currently scheduled for 2021. There are nine (9) dates throughout the year for mandatory Department training that all officers will attend. This year's training includes several modules that comprise the *Integrating Communications, Assessment and Tactics (ICAT)* program developed by the Police Executive Research Forum (PERF).

The topics of the modules are:

Module 1-Introduction

Module 2-Critical Decision-Making Model

Module 3-Crisis Recognition

Module 4-Tactical Communications

Module 5-Operational Tactics

Module 6-Integration and Practice (Scenarios)

In addition to ICAT training, other topics to be covered in the mandatory Department include:

-CPR

-Diversity (Inclusive Language, Micro-aggressions, Socio-economics)

-Defensive Tactics (w/baton, edged weapons)

-Domestic Violence

By month, here are training events scheduled to date that include BPD personnel, personnel from other police agencies, and outside instructors conducting the courses:

January: Mental Health First Aid (MHFA)

February: Mandatory Department Training (x3), Crisis Intervention Training (CIT), Mental Health First Aid (MHFA)

March: Mandatory Department Training (x3)

April: Mandatory Department Training (x2), Designated Marksman, Patrol Rifle, MHFA

May: Mandatory Department Training (x1), Law Enforcement Resiliency Peer Support

(LERP), MHFA, Field Training Officer (FTO) School

Also in May, BPD will be hosting and providing most instructors for the Indiana Law Enforcement Academy (ILEA) Basic Course. This is a 15 week course designed to attract newly-hired officers who can commute to Bloomington from law enforcement agencies in this region. It is intended to help with the backup of training at ILEA caused by the COVID-19 pandemic and it is quite a compliment for the Law Enforcement Training Board (LETB) to consider BPD for providing this critical training to recruit officers.

## Hello Chief,

My name is Chris Anderson. I am a detective with the Lawrence County Sheriff's Dept. I just wanted to take a moment and compliment one of your officers, Justin Tabor, on an outstanding job. I recently had the pleasure to work closely with him all last week on a vehicle theft from the Dollar General next to Johnny Junxions down here. Officer Tabor recovered the stolen vehicle for me on Tuesday night 02/02. I provided some information to Officer Tabor and stayed in contact with him after meeting him on Tuesday night. He initiated contact with me and provided me with information as well, which he did not have to do, and began putting some names with some faces I had from security footage. Officer Tabor located three of the suspects on Thursday night 02/04 and detained them at the Bloomington PD for me so I could question them. On Friday night 02/05, Officer Tabor advised me he had located and had in custody the offending individual, who happened to also be wanted as a runaway juvenile.

Officer Tabor undoubtedly went well above and beyond his call of duty in assisting me with this case, and I could not have cleared this case without his assistance. I am sure other officers were involved throughout this process, but I was in contact with Officer Tabor for the duration of this case. I just wanted you to know what a fine officer Justin Tabor is and to be aware of the effort and care he clearly puts into his work.
