In Bloomington, Indiana on Wednesday, October 21, 2020 at 6:30pm, Council President Stephen Volan presided over a Regular Session of the Common Council. Per the Governor's Executive Orders, this meeting was conducted electronically.

Council President Stephen Volan summarized the agenda.

Piedmont-Smith moved and it was seconded to approve the Regular Session Minutes of February 19 as amended, March 04 as amended, July 22 as amended, and October 07, 2020 as amended. The motion received a roll call vote of Ayes: 9, Nays: 0, Abstain: 0.

APPROVAL OF MINUTES [6:36pm]

Smith said that his neighbor Dick Scott turned 99 years old and wished him a Happy Birthday.

REPORTS

Sims said Happy Birthday to Mr. Scott.

• COUNCIL MEMBERS [6:37pm]

Rollo wished Mr. Scott a Happy Birthday. Rollo also reminded people to continue taking safety precautions to reduce the transmissibility of the virus.

Sandberg said that Star Trek: Voyager's Captain Kathryn Janeway statue was due to be unveiled on the upcoming weekend. She noted that Janeway would be born in the future on May 20, 2336.

Volan echoed Sandberg's comments. He also discussed the city and county budgets in lieu of his absence at the adoption meeting. He specifically expressed dismay and wished that the City and County fire departments could be streamlined to save taxpayer money. He stated that he felt the county budget for fire protection service was excessive when those services may be provided by city fire protection personnel.

Rollo said that adding the monument to Captain Janeway would put the city in line for an attack from the Romulans, but he felt it was worth the risk.

Beth Rosenbarger, Planning Services Manager; Mallory Rickbeil, Bicycle and Pedestrian Coordinator; Amir Farschi, Long Range Planner; and Keegan Gulick, Zoning and Long Range Planner; of the Planning and Transportation Department gave an update on the Comprehensive Plan.

There was council discussion related to the presentation.

There were no council committee reports.

Jim Shelton gave a report about CASAs (Court Appointed Special Advocates).

There were no appointments to boards or commissions.

APPOINTMENTS TO BOARDS AND COMMISSIONS [7:39pm]

COUNCIL COMMITTEES

Piedmont-Smith moved and it was seconded that <u>Ordinance 20-17</u> be read by title and synopsis only. The motion was approved by voice vote. Clerk Nicole Bolden read the legislation by title and synopsis, giving the committee do-pass recommendation of Ayes: 4, Nays: 0, Abstain: 0.

Piedmont-Smith moved and it was seconded that <u>Ordinance 20-17</u> be adopted.

Rickbeil, Bicycle and Pedestrian Coordinator for the Planning and Transportation Department, presented the legislation.

Rosenbarger reported on the Transportation Committee's meeting where they discussed this ordinance. The committee liked the proposed changes for the most part.

Piedmont-Smith inquired about the removal process.

Rickbeil answered it required signatures from a majority of residents and a seven year waiting period between when the traffic calming had been approved and when a neighborhood could request the removal. It also needed to be approved by the Bicycle Pedestrian Safety Commission (BPSC).

Piedmont-Smith asked if there was any recourse sooner than seven years if unforeseen negative impacts were recognized.

Rickbeil responded that there was a clause that provided for the Planning Department to take action. It required that the City Engineer support the change.

Rollo asked if Fire, EMT and Police would be consulted before implementation of traffic calming features.

Rickbeil said that the process included their input.
Rollo asked if data was kept on bicycle and pedestrian crashes.
Rickbeil did not think that they had those types of records.

Sims asked for a definition of housing units that were affected by the traffic calming measures.

Rickbeil said affected housing units were defined as residents or property owners of record who were located within 2 lots but not to exceed 300 feet of streets that were affected by the traffic calming installation.

Sgambelluri asked for further clarification of affected housing units.

Rosenbarger asked about the traffic calming projects in the Countryside neighborhood.

Rickbeil elaborated about the signatures that were obtained.

Smith asked when the program would begin.

Rickbeil said that if the ordinance passed, it would take effect in November 2020.

Smith asked how citizens would be notified of the new policy. Rickbeil said there would be a concerted effort to get the word out starting in January 2021.

Rosenbarger moved and it was seconded to introduce Amendment 01 to <u>Ordinance 20-17.</u>

Synopsis: This amendment is sponsored by Councilmember Rosenbarger. The amendment reduces the percentage of signatures required from Affected Housing Units impacted by a proposed traffic calming installation in an effort to simplify the resident-led traffic calming process, improve efficiency, and remove unnecessary barriers to traffic calming installations.

Rosenbarger presented the Amendment 01.

Rickbeil spoke in favor of the Amendment 01.

Rollo asked if the Planning Department had data on speeding in residential neighborhoods that would be used to qualify applications.

Rickbeil responded that they would use 5 years of data when evaluating the applications.

Rollo asked how that was qualified.

Rickbeil explained the rubric that would be used to analyze applications.

Rollo asked if the council would have a say on the approval of the rubric.

Rickbeil said that the council would not be involved in setting those priorities.

Sims expressed his concern that fewer residents would have the ability to apply when not all the residents in the area supported the addition of traffic calming features.

Sgambelluri asked how many residents it would take to stop the addition of traffic calming features in a neighborhood.

Rosenbarger reminded the Council that the Amendment 01 was for the application for traffic calming grants, not for approval of the project.

Rickbeil added that after an application had been accepted, a hearing would take place for residents of the neighborhood.

Greg Alexander spoke in favor of the Amendment 01. Public comment:

Katie Yoder spoke in favor of the Amendment 01.

Rollo spoke in favor of the Amendment 01. Council comments:

Smith spoke in favor of the Amendment 01.

Volan spoke in favor of the Amendment 01.

Sgambelluri asked how the city proposed to maintain the paint on Council discussion: the speed cushions that were added.

Rickbeil believed that Public Works expressed a need for additional funds to maintain them because the current budget was already earmarked for other needs.

Rosenbarger said <u>Ordinance 20-17</u> had been vetted with Public Works.

Rollo expressed his appreciation for Ordinance 20-17.

Sims thanked Planning and Transportation for working on <u>Ordinance 20-17</u>.

Flaherty stated his appreciation for <u>Ordinance 20-17</u> and asked if council could be informed about projects that were funded and those that were not.

Rickbeil said that would be possible.

Piedmont-Smith expressed her support of Ordinance 20-17.

Sgambelluri congratulated Planning and Transportation on Ordinance 20-17 and stated her support of it.

Volan expressed support for Ordinance 20-17.
